AFFIDAVIT OF S. DEREK BAUER IN SUPPORT OF
DEFENDANT LFP PUBLISHING GROUP, LLC'S BILL OF COSTS

1. My name is S. Derek Bauer. I have been a member of the State Bar of Georgia since 2000. I am over the age of eighteen and suffer from no disability or other impairment that affects my ability to provide testimony.

2. I am a partner in the law firm of McKenna Long & Aldridge LLP and am counsel for Defendant LFP Publishing Group, LLC in the above-captioned matter.

3. This affidavit is filed in support of the Defendant LFP Publishing Group, LLC's Bill of Costs filed in this action pursuant to 28 U.S.C. § 1920 and Federal Rule of Civil Procedure 54(d), and is based upon my personal knowledge and upon business records and case file materials maintained by me or by personnel working under my direction and supervision.

4. The Bill of Costs submitted herewith by Defendant LFP Publishing Group, LLC is a true and accurate reflection of the costs paid by Defendant in defense of Plaintiff's claims. Although Defendant also paid attorneys' fees and other costs, the Bill of Costs reflects only those costs that are properly and clearly taxable pursuant to 28 U.S.C. § 1920.

5. The fees for costs of the court reporters for all or any part of transcripts necessarily obtained for use in this case total \$116.40. See 29 U.S.C. § 1920(2). The only transcript necessarily obtained by Defendant for use in this case is the transcript of the proceedings before the Court on February 8, 2008. A copy of the invoice for this transcript is attached hereto as Exhibit 1.

6. The fees for exemplification and copies of paper necessarily obtained for use in the case are \$108.75. See 28 U.S.C. § 1920(4). Exemplification fees consisting of service and, where appropriate, filing copies of all pleadings were required and necessary for the defense of this action. This total consists only of exemplification fees and copies of papers necessary for use in the case.

7. The fees of the clerk necessarily incurred by Defendant LFP Publishing Group, LLC in its defense of this case include this Court's \$350.00 removal and \$185.00 filing fees.

8. Therefore, as set forth above and in the Bill of Costs submitted herewith, the total costs that are taxable to Plaintiff equal \$760.15.

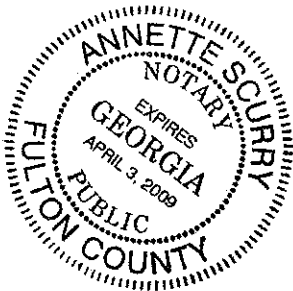
