deposed and said as follows:

1.

My name is Christopher Lee Helton. I am over twenty-one (21) years of age and I am competent to make and give this Affidavit, and do so from personal knowledge.

#### 2.

I am a professional photographer who specializes in taking pictures of musical performers and other celebrities.

#### 3.

During the 1980's, I was a resident of Orlando, Florida.

#### 4.

I was present at a modeling session and photo shoot involving Nancy Benoit, then known as Nancy Daus, that took place in the early to mid-1980's at the townhouse of Mark Samansky. Also present at the photo shoot were Mark Samansky, Ms. Benoit's then-husband, Jim Daus, and another photographer, Bill Otten.

At the photo shoot, I used my camera to take photographs of Ms. Benoit while she posed nude, partially nude, and in various outfits. Ms. Benoit's participation in the photo shoot was voluntary and consensual. The modeling

session was also recorded photographically by Bill Otten with his camera, and recorded by Mark Samansky on videotape.

6.

I recognize the images of Nancy Benoit published in the March 2008 issue of *Hustler* Magazine as images taken from the same modeling session with Ms. Benoit at the home of Mark Samansky that I participated in.

7.

To the best of my recollection, a short time after the modeling and photo session I met Ms. Benoit and Jim Daus to show them the pictures I had taken and to give them a set of copies of those pictures.

8.

With Ms. Benoit's full knowledge and consent I retained a set of copies of the pictures I took of her during the modeling session, as well as the negatives.

9.

Neither Ms. Benoit, Jim Daus, Mark Samansky or anyone else ever asked me, at any time, to destroy the photographs I took of Ms. Benoit or the negatives of those photographs.

## 10.

To the best of my recollection, I have not destroyed the photographs I took of Ms. Benoit or the negatives for the photographs.

## 11.

I have never authorized the publication of the nude photographs I took of Ms. Benoit, and to the best of my knowledge, none of those photographs have ever been published.
