

EE. Professor Thompson

2859. Professor Thompson is not currently employed as a professor at Georgia State University.

1) EPY7080 – Summer 2009

2860. Professor Thompson taught EPY7080 during Summer 2009.

2861. Thirty-one students enrolled in Professor Thompson's section of EPY7080.

2862. Professor Thompson required his students to purchase the following works for EPY7080: Human Learning (Omrod).

i. Handbook of Adult Development Learning

2863. Professor Thompson used an excerpt from the work Handbook of Adult Development Learning while teaching EPY7080 during Summer 2009.

2864. Handbook of Adult Development Learning is published by Oxford.

2865. Handbook of Adult Development Learning is 595 pages long.

2866. Handbook of Adult Development Learning is a collective work made up of works from several different contributors.

2867. Handbook of Adult Development Learning is not owned by Oxford by an assignment.

2868. The excerpt of Handbook of Adult Development Learning Professor Thompson placed on Georgia State University's ERes system is a single work provided by one contributor, and that contributor did not assign or grant an exclusive license to the work to Oxford.

2869. Professor Thompson prepared a fair use checklist prior to requesting that the library put the excerpt of the work on Georgia State University's ERes system.

2870. Professor Thompson did not print his fair use checklist for the excerpt of Handbook of Adult Development Learning.

2871. The excerpt of Handbook of Adult Development Learning that was placed on Georgia State University's ERes system was 26 pages long, and constituted approximately 4.4% of the work.

2872. The excerpt of Handbook of Adult Development Learning that was placed on Georgia State University's ERes system was used for a nonprofit, educational purpose. Namely, the excerpt was used as part of Professor Thompson's course materials for the purpose of teaching his class, and neither Professor Thompson, Georgia State University, nor the named defendants profited from the use of the excerpt of Handbook of Adult Development Learning.

2873. The excerpt of Handbook of Adult Development Learning that was placed on Georgia State University's ERes system was not used for commercial purposes.

2874. The excerpt of Handbook of Adult Development Learning that was placed on Georgia State University's ERes system was used by Professor Thompson for the purpose of teaching the students in his course.

2875. Neither Georgia State University, Professor Thompson, nor the named Defendants profited from the use of the excerpt of Handbook of Adult Development Learning that was placed on Georgia State University's ERes system.

2876. Handbook of Adult Development Learning is a published work.

2877. Handbook of Adult Development Learning is a factual work of nonfiction.

2878. The excerpt of Handbook of Adult Development Learning that Professor Thompson used in his course amounts to 4.4% of the work, and as such, was a small portion of Handbook of Adult Development Learning.

2879. The excerpt of Handbook of Adult Development Learning that Professor Thompson used in his course was not central to the work.

2880. Professor Thompson's use of the excerpt of Handbook of Adult Development Learning did not have a significant effect on the market or potential market for the copyrighted work because the ERes excerpt was restricted to his class.

2881. Access to the excerpt of Handbook of Adult Development Learning was limited to the students in the class by a password protected website.

2882. The excerpt of Handbook of Adult Development Learning was removed from the ERes system after the semester ended.

2883. GSU lawfully owns a copy of Handbook of Adult Development Learning.
