**IT FURTHER APPEARING** to this Court that continued membership in the Bar of this Court is contingent upon the attorney maintaining active status in good standing with the State Bar of Georgia (LR 83.1F),

**IT IS THEREFORE ORDERED:**

(1) that the above-named attorneys be suspended from the Bar of this Court;

(2) that this Order shall become effective as an order of permanent suspension from this Court's Bar thirty (30) days following this date unless proceedings consistent with LR 83.1F are initiated by the attorney;

(3) that the Clerk of Court is authorized to reinstate any of the named attorneys to the Bar of this Court upon receipt of an original certified statement from the State Bar of Georgia that he or she is an active member in good standing of the State Bar of Georgia; and


(4) that the Office of the Clerk advise each of the named attorneys of this action by forwarding a copy of this Order by certified mail to each attorney at their last known address.
