#### ASSIGNMENT AGREEMENT

1. <u>Assignment</u>. Assignor hereby assigns and transfers unto Assignee any and all of his right, title and interest in and to the Policies.

2. <u>Assumption</u>. Assignee hereby accepts the foregoing transfer and assignment of the Policies.

3. <u>Counterparts</u>. This Assignment may be executed by the Parties in separate counterparts, each of which when so executed and delivered shall be an original, but all such counterparts shall together constitute one and the same instrument. A signed copy of this Assignment delivered by facsimile, email or other means of electronic transmission shall be deemed to have the same legal effect as delivery of an original signed copy of this Assignment.

4. <u>Modification</u>. This Assignment may not be amended except by a written agreement executed by each of the parties hereto.

5. <u>Successors and Assigns</u>. This Assignment shall be binding upon and inure to the benefit of the parties hereto and their successors and permitted assigns.
