ORDER

Before the Court are (1) Plaintiffs' and Defendant Cyprus Amax Minerals Company's ("Cyprus Amax") joint motion to dismiss Defendant Cyprus Amax (Doc. 197) and (2) Defendant Cyprus Amax's motion for summary judgment (Doc. 53).
