UNLIMITED CONTINUING GUARANTEE

FOR VALUE RECEIVED, and to induce Green Bay Packaging, Inc. of Green Bay, Wisconsin (hereinafter "GBP") to extend credit to <u>Midwest Packaging LLC.</u>

PO Box 681. Hoffman Estates. II. 60195 (hereinafter "Debtor"), <u>Fred Oscarson</u>

and Jeff Oscarson (hereinafter "Guarantor") hereby guarantees payment of and promises to pay when due, or at the time Debtor becomes a subject of bankruptcy or other insolvency proceedings, all debts, obligations and liabilities of Debtor to GBP, including interest, late charges and all payments from Debtor to GBP which are returned by GBP to a trustee, receiver, creditor or other party pursuant to state or federal law. Guarantor further guarantees payment of and promises to pay all costs, expenses and fees that are incurred at any time by GBP in endeavoring to collect any sums from Debtor or Guarantor. This Guarantee is valid and enforceable against Guarantor even if Debtor's obligations to GBP should become invalid and unenforceable.

WAIVER. Guarantor expressly waives notice of default by Debtor as well as proceedings to collect from Debtor for any such default and further waives any requirements of diligence of collection, presentment, demand, notice or protest.

REPRESENTATIONS. Guaranter acknowledges and agrees that GBP has not made any representations or warranties with respect to Debtor's obligations to GBP, or with respect to the financial condition of Debtor. Guaranter has independently determined the collectability and enforceability of Debtor's obligations to GBP and the financial condition of Debtor.

REVOCATION. This is a continuing Guarantee and shall remain in full force and effect until GBP receives written notice of revocation from Guarantor. Upon such revocation by written notice, this Guarantee shall continue in full force and effect as to all obligations contracted for or incurred before revocation, and as to them GBP shall have the rights provided by this Guarantee as if no revocation had occurred. Any renewal or extension of an existing contract between Debtor and GBP, whether made before or after revocation, and any materials provided by GBP to Debtor pursuant to commitments made before revocation shall constitute obligations contracted for or incurred before revocation.

SUBROGATION. Guarantor waives any claim, right or remedy which Guarantor may now have or hereafter acquire against Debtor or any person primarily or contingently liable for the guaranteed obligations or that arise from the existence or performance of Guarantor's obligations hereunder, including, without limitation, any claim, remedy or right of subrogation, reimbursement, exoneration, contribution, indemnification or participation in any claim, right or remedy of GBP against Debtor or any collateral security GBP now has or hereafter acquires regardless of how such claim, remedy or right arises.

PERSONS BOUND. This Guarantee benefits GBP, its successors and assigns, and binds Guarantor, its successors and assigns.
