**MOTION TO WITHDRAW MOTION TO RE-OPEN CASE AND
ENTER JUDGMENT AGAINST JEFFREY OSCARSON**

Green Bay Packaging, Inc., (“Green Bay”), by and through its attorneys, moves this Court for the entry of an Order authorizing it to withdraw without prejudice, its Motion to Re-Open Case and Enter Judgment against Jeffrey Oscarson (“Motion”) (Docket Number 48) and in support thereof, Green Bay states as follows:

1. Following presentation of this Motion, the parties appeared before the Bankruptcy Court on Jeff Oscarson’s Motion to Reconsider the Bankruptcy Judge’s decision.
2. Because Bankruptcy Judge Hollis is not sitting until mid-September, 2008, the Bankruptcy Court may not decide Jeff Oscarson’s Motion to Reconsider until then, at the earliest.
3. Accordingly, Green Bay suggests that cause exists to withdraw its instant Motion before this Court pending resolution of Jeff Oscarson’s Motion to Reconsider pending before the Bankruptcy Court.

Wherefore, Green Bay requests that this Court enter an Order (1) authorizing it to withdraw its Motion to Re-Open Case and Enter Judgment Against Jeff Oscarson, without

Prejudice; (2) striking the Briefing Schedule set forth in the Court's Minute Order of July 24, 2008; (3) striking the status hearing on this matter previously set for July 31, 2008; and for such other and further relief as this Court deems appropriate under the circumstances.
