Lance,

The document that you sent by e-mail regarding your financial information was not in Word format. The file extension was .wps, and I was not able to open in either in WordPerfect or in Word. The firm's computing people were able to view a portion of the document, but not all of it. I received your FedEx package on Monday that contained a cover letter, two sets of credit information, and unsigned "draft" tax forms for 2005 and 2006. If you have any additional information to provide that was not included in that packet, I would ask that you either send a hard copy or a fax to me at 312-630-7349.

Your tax forms raise a lot of questions. As I mentioned in court, you show income of \$161,000 in wages and salary for both years, but you did not send us W-2s or any other documents that support the numbers in your tax forms. The schedules to the tax returns show information related to various companies, a rental property, and other income from investments, but you have provided us with no information regarding any of those, and certainly no information that we could verify or that my client could use as a basis for agreeing to a settlement.

Your statements in court on Tuesday morning indicated that you are expecting my client to agree to drop this lawsuit based on your current financial condition. You have referred to a "nominal settlement" but have not specified what such a settlement would be. If you would like for settlement discussions to move forward, perhaps you could let me know exactly what you are offering so that we could take it back to the client and discuss.

Judge Moran also suggested that we discuss your current discovery responses. I refer you to Federal Rule of Civil Procedure 36. Rule 36 requires that the reasons for any objection be stated; thus, references to your "general objections" are improper. Further, "[a]n answering party may not give lack of information or knowledge as a reason for failure to admit or deny unless the party states that the party has made reasonable inquiry and that the information known or readily obtainable by the party is insufficient to enable the party to admit or deny." Thus, responses like "not within the scope of my information and belief" are improper. Additionally, Rule 36 requires that you either admit or deny each request, or "set forth in detail the reasons why the answering party cannot truthfully admit or deny the matter." In many of your responses, you do not admit or deny, but rather make a statement about your interpretation of DDN's agreement with Deluxe - see, for example, Request No. 100. Please provide any amended responses to the requests for admission by December 30, so that we can review them in advance of the hearing on January 2.
