

- 2 MR. BERNS: For the record, Louis Berns on
- 3 behalf of the defendant. Defendant's signing a jury
- 4 waiver.
- 5 THE COURT: Can we talk about this?
- 6 MR. BERNS: We can approach if you like.
- 7 THE COURT: Sure. Come on up.
- 8 (Whereupon a discussion was had off
- 9 The record.)
- 10 THE COURT: You know what I have to get a trial
- 11 book.
- Ms. Elizondo, your attorney handed me a document
- 13 let me start off by saying you're charged with battery,
- 14 you understand that?
- THE DEFENDANT: Yes.
- 16 THE COURT: My understanding you are pleading not
- 17 guilty, is that correct?
- 18 THE DEFENDANT: Correct.
- 19 THE COURT: Your attorney handed me this document
- 20 entitled jury waiver, did you sign this?
- 21 THE DEFENDANT: He just asked me to sign it.
- 22 THE COURT: You understand what you signed, let
- 23 me tell you this, a jury trial you can have a jury
- 24 trial where you pick 12 people they sit right there

- 1 you pick them, your lawyer picks them, the State's
- 2 Attorney picks them those 12 people decide your
- 3 guilt or innocence on this case, do you understand
- 4 that?
- 5 THE DEFENDANT: Yes.
- 6 THE COURT: Did you know when you signed this you
- 7 waive that right you have a right to that jury you
- 8 understand that?
- 9 THE DEFENDANT: Yes.
- 10 THE COURT: You want me to hear this what we
- 11 call a bench trial, I'm going to make the decision based
- 12 upon the facts and evidence that I hear in determining
- 13 whether you're guilty or innocent?
- 14 THE DEFENDANT: Yes.
- 15 THE COURT: Is that what you want?
- 16 THE DEFENDANT: Yes.
- 17 THE COURT: You sure?
- 18 THE DEFENDANT: Yes.
- 19 THE COURT: Okay. Jury waiver executed. Any
- 20 preliminary motions?
- MR. BERNS: Motion to exclude.
- 22 THE COURT: Motion everyone testifying come on
- 23 up. There has been a motion to exclude that means
- 24 you're not to discuss your testimony. Everyone

- 1 understand that during the pendency of the trial,
- 2 understand that?
- 3 THE WITNESSES: Yes.
- 4 THE COURT: Swear the witnesses.
- 5 (Witnesses duly sworn.)
- 6 THE COURT: You understand English?

- 11 Any other motions? There has been a motion to exclude.
- 12 Motion to exclude. Any opening statements?
- 13 MR. BERNS: I'll waive.
- 14 MR. RUSSELL: Waive.
- 15 THE COURT: Call first witness.
- 16 Stand next to your attorney. Make sure you speak up so
- 17 my Court Reporter can hear.
- 18 THE WITNESS: I just had a root canal.
- 19 THE COURT: Take your time.
- 20 Go ahead.
- 21 OFFICER DUBINKA,
- 22 the witness herein, having been first duly
- sworn, was examined and testified as follows:

1 DIRECT EXAMINATION 2 BY MR. RUSSELL: 3 Officer, state your name, badge number, Q 4 employment? Officer Michael Dubinka, Star 103, Summit 5 Α 6 Police Department. Officer, were you employed with Summit Police 7 Department -. 9 THE COURT: What was your first name? 10 THE WITNESS: Michael. 11 THE COURT: How do you spell your last name? 12 : THE WITNESS: D-u-b-i-n-k-a. Go ahead. 13 THE COURT: 14 MR. RUSSELL: Q You were so employed with Summit Police Department on May 21, 2006, approximately 2:00 15 o'clock in the morning? 16 17 Yes, I was. 18 On that date and time did you have occasion 19 to go to 6303 Archer in Summit? 20 Α Yes, I did.

What's located there?

There is a bar there called -.

A bar called what?

Laduenya (phonetic), it's changed

- 1 names several times.
- 2 THE COURT: It's a bar?
- 3 THE WITNESS: Yes.
- 4 MR. RUSSELL: Q Were you dispatched to that location?
- 5 A Yes, I was.
- Q When you got to that location did you meet
- 7 with somebody?
- 8 A Yes, I did.
- 9 Q Who did you meet with?
- 10 A Well, there was another officer there already
- 11 there was large group of people outside, injured subject.
- 12 Q Who was the other officer you went with?
- 13 A Officer Brendal.
- 14 THE COURT: Brendal?
- 15 THE WITNESS: Yes.
- MR. RUSSELL: Q You stated somebody there was injured?
- 17 A Yes.
- 18 Q Is that person in this courtroom today?
- 19 A I don't know if he was or not.
- 20 Q What was your reason for going to this location?
- 21 A Because we had a call there was a fight
- 22 there was an injured person.
- Q What, if anything, who else was present at
- 24 this location at that time?

- 1 A The subject that was arrested and there was
- 2 some men out there. I don't know who they were. They
- 3 were patrons of the bar. There was patrons from the
- 4 other bar coming out because the commotion. There was
- 5 ambulance on the scene.
- 6 Q And while you're on the scene with this
- 7 injured person what, if anything, unusual happened?
- 8 A We are trying to get any information who
- 9 the offenders were and the victim was speaking with
- 10 Officer Brendal. He says anybody that was out there
- 11 was not them. We asked people in the crowd. He couldn't
- 12 identify anybody. He said he thinks they had left.
- 13 I was asking people outside that walked out of the
- 14 bar if they seen what happened. They said, no, but
- 15 happened on the outside when they were leaving. The
- 16 offender and the offender and the victim.
- 17 Q Then what happened?
- 18 A I was continuing ask them what was going on.
- 19 I noticed that the female subject that was there was
- 20 screaming at Officer Brendal.
- Q Do you see the female subject in the courtroom
- 22 that was screaming at Officer Brendal?
- 23 A Yes, I do.
- Q Please point to that female -.

- 1 MR. BERNS: Stipulate to in-court I.D.
- 2 THE COURT: In-court identification of the
- 3 defendant by stipulation and actual testimony. Go ahead.
- 4 MR. RUSSELL: Q What, if anything, did you observe
- 5 the defendant do when she was screaming at Officer
- 6 Brendal?
- 7 MR. BERNS: Objection, foundation, where he was
- 8 proximity.
- 9 THE COURT: Can we be more specific.
- MR. RUSSELL: Q When the defendant was screaming at
- 11 Officer Brendal approximately how far away were you?
- 12 A 10 to 15 feet.
- Q What were the lighting conditions?
- 14 A Street lights. There are lights from vehicles
- 15 parked there.
- Q Who else was present?
- 17 A Like I said there was customers from the bar
- 18 the ambulance crew was there. At that point or not they
- 19 were there because the victim refused any medical
- 20 transportation or aid, I quess he signed a waiver. I
- 21 don't know if they were still there at that point or not.
- Q From 10 to 15 feet away observing the defendant
- 23 yelling at Officer Brendal what did you next observe?
- A While he was talking to the victim she ran

- 1 at him he wasn't expecting it because he wasn't
- 2 looking at her when she shoved him he fell backwards
- 3 several feet. She backed away from him at that point.
- 4 O Did he lose balance or was he able to maintain
- 5 balance?
- A He maintained balance. He stepped backwards
- 7 put arms against a concrete call there.
- 8 Q Then what happened?
- 9 A I started walking over to that direction he
- 10 was telling her that you're under arrest because he had
- 11 been warning her to stay away from him. She admitted
- 12 to him she hadn't seen anything she was in the bathroom.
- 13 I heard her telling him she kept screaming and yelling
- 14 this whole time when I was approaching her she started
- 15 wacking him again I told her to stop.
- Q After you told her to stop what happened?
- 17 A She raised up her arms started going at him
- 18 again.
- 19 Q Then what happened?
- 20 A I walked in between the two of them at that
- 21 point I held my can of department issued pepper spray.
- 22 I warned her I would spray her if she continued to go
- 23 towards him.
- Q Then what happened?

- 1 A She continued at it with arms and waving at
- 2 that point I sprayed her.
- 3 Q Then what happened?
- 4 A Officer Brendal had gotten a little bit of
- 5 the effects also on him like a cross contamination she
- 6 was still in motion going towards him. I grabbed her I
- 7 handcuffed her at that point like I said group of people
- 8 out there I handcuffed her the ambulance people I
- 9 think at that point were also talking to him about
- 10 possibly giving him some type of treatment at that point
- 11 for his affects of the pepper spray that he got out.
- Q When you say he who are you referring to?
- 13 A Officer Brendal.
- 14 Q Then what happened?
- 15 A Took her to the police station.
- Q Who transported her to the police station?
- 17 A I don't remember.
- 18 Q Did you also go to the police station?
- 19 A Yes, I did.
- Q What, if anything, happened at the police station?
- 21 A She is crying finally she apologized she said -.
- THE COURT: She is crying?
- 23 THE WITNESS: Yes.
- 24 THE COURT: What else?

- 1 THE WITNESS: She told us that she was sorry.
- 2 MR. RUSSELL: Q After she said she was sorry -.
- 3 MR. BERNS: Could he finish his testimony.
- 4 THE COURT: I'm sorry I interrupted too. She
- 5 was crying. She said she was sorry. You may continue.
- 6 THE WITNESS: She is embarrassed she said she is
- 7 a relative is a police officer. She knows she couldn't
- 8 act like that.
- 9 MR. RUSSELL: Q After she admitted being sorry for this
- 10 offense what happened?
- 11 MR. BERNS: That's assuming testimony not in
- 12 testified she said sorry. I don't think the words -.
- 13 THE COURT: The evidence stands. Testimony stands.
- 14 You may ask the next question.
- MR. RUSSELL: Q After she said she was sorry what
- 16 happened next?
- 17 A We continued to process her and she mentioned
- 18 again about being sorry. I told her she should apologize
- 19 to Officer Brendal that the officer she committed
- 20 battery on.
- Q What, if anything, did she say at that point?
- 22 A At that point I was doing other things I
- 23 know she talked to him. I don't know what she said to
- 24 him at that time. She approached Officer Brendal at the

- 1 time she was bonding out.
- 2 MR. RUSSELL: Nothing further.
- 3 THE COURT: Your witness.
- 4 CROSS EXAMINATION
- 5 BY MR. BERNS:
- 6 Q Morning, Officer, this happened in May of
- 7 2006?
- 8 A Yes.
- 9 THE COURT: I can't hear. Speak louder.
- 10 MR. BERNS: Q Possibly Officer if you talk to the
- 11 Judge.
- 12 THE COURT: I can hear.
- 13 MR. BERNS: Q Sir, this happened May 21, 2006, 2:00
- 14 a.m.?
- 15 A Correct.
- 16 Q Were you and Brendal working as partners or
- 17 individual cars?
- 18 A Individual cars.
- 19 Q All you knew at the time there was a bar fight?
- 20 A At that point, yes.
- 21 Q You heard there were injuries someone summoned
- 22 an ambulance?
- 23 A Yes.
- Q Truth be told you didn't know what to expect?

- 1 A No, I didn't.
- 2 Q Could have been a fight in progress?
- 3 A Yes.
- Q When you got there, there was no fight in
- 5 progress?
- 6 A No.
- 7 Q Basically, your role was to investigate and
- 8 give aid or assistance if there was anybody injured?
- 9 A Correct.
- 10 Q The first person you approached was the
- 11 alleged victim of this battery, is that correct?
- 12 A Officer Brendal was already talking to him
- 13 I was heard part of the conversation.
- 14 Q Basically, from what you heard he was
- 15 describing what happened, your role with Officer Brendal
- 16 trying to identify the perpetrator?
- 17 A Yes.
- 18 Q But, people were disbursed was this outside or
- 19 inside the bar?
- 20 A Outside.
- Q When was the first time you saw or came into
- 22 contact with my client the defendant sitting next to me?
- 23 A Shortly after we got there because she was
- .24 shouting.

- 1 Q And did she have any relationship that you
- 2 were aware of with the initial victim of this battery
- 3 which you were summoned to the location?
- 4 A I related or appeared .
- 5 Q Did it appear they were boyfriend girlfriend
- 6 they came together?
- 7 THE COURT: Did you know if they had a relationship
- 8 at all?
- 9 THE WITNESS: I don't know.
- MR. BERNS: Q Did she ever indicate that to you?
- 11 A She was concerned about him she said she came
- 12 with him there. I don't know why she was with him.
- 13 Q At least you knew they came together?
- 14 A They were in the bar together.
- 15 Q She wasn't just some patrol trying to get
- 16 involved in something didn't know about, didn't know the
- 17 victim?
- 18 A Right.
- 19 Q And did it appear she was concerned what had
- 20 taken place?
- 21 MR. RUSSELL: Objection as to what she appeared.
- 22 THE COURT: Sustained.
- MR. BERNS: Q Did her initial what was her initial
- 24 comments when began this investigation, if you recall?

- 1 A She kept saying things like do something
- 2 about it, arrest somebody.
- 3 Q She seemed to be aggravated what had taken
- 4 place, is that a fair statement?
- 5 A Yes.
- Q Initially, did she batter you or Officer Brendal
- 7 when she first described to you she was aggravated want
- 8 you to arrest somebody what happened to your friend?
- 9 A I don't understand.
- 10 Q Did she ever touch you ? Did she put hands on
- 11 you at any time?
- 12 A No.
- 13 Q How about when you pepper sprayed her?
- 14 A No, cause I grabbed her arms right away she
- 15 was putting her hands in her face.
- 16 Q You pepper sprayed her she was not getting
- 17 handcuffed or subdued?
- 18 A Huh?
- 19 Q Initially when you pepper sprayed her, her
- 20 hands were still free?
- 21 A I didn't have her in custody.
- Q When you pepper sprayed her how far away were
- 23 you from her?
- 24 A Several feet.

- 1 Q She battered you prior to you pepper spraying
- 2 her?
- 3 A No.
- Q I understand from your testimony there was
- 5 some cross contamination?
- 6 A Yes.
- 7 Q My client ever raise her hands and have you
- 8 point the pepper spray towards Officer Brendal?
- 9 A No.
- 10 Q So, my client the battery we're talking about
- 11 has nothing to do with pepper spray you shot at her,
- 12 right, correct?
- 13 A I don't understand what you mean.
- 14 Q This is allegation of battery. I want to
- 15 make sure the battery doesn't also include pepper spray
- 16 that there was cross contamination against Officer
- 17 Brendal?
- 18 A Battery when she went after him the first time.
- 19 Q We'll talk about that. So, after you first
- 20 met her to kind of fast forward the story here, what
- 21 happened next regarding my client's interaction with you
- 22 and Officer Brendal?
- A She was loud, screaming, swearing.
- 24 Q This is all part of this initial encounter,

- 1 is that like a continuation so that I understand
- 2 what happened?
- 3 A Yes.
- Q By the way, did you or Officer Brendal
- 5 did you have vest on at that time?
- 6 A Yes.
- 7 Q Was Brendal wearing his vest under his shirt
- 8 or over his shirt if you recall?
- 9 A I don't recall.
- 10 Q I assume I won't assume anything, was my
- 11 client interfering with your investigation from your
- 12 perspective?
- 13 A Yes.
- 14 O You found her voice and comments as frustrating?
- 15 A She was interfering. She couldn't identify
- 16 anybody. She told us she was in the bathroom. Officer
- 17 Brendal told her to stay back stay away. He kept
- 18 strying to talk to the victim. I was trying to ask any
- 19 of the patrons if they had seen anything.
- 20 Q At that point before any contact she was
- 21 basically being a pain in the rear regarding your
- 22 investigation, is that a fair statement?
- 23 A Obstructing us.
- 24 THE COURT: What did you say?

- 1 THE WITNESS: She was obstructing us. She
- 2 wouldn't she continued to interrupt us when trying to
- 3 talk to other people.
- 4 MR. BERNS: Q She was interrupting. She was
- 5 aggravated what had taken place, correct?
- 6 A I guess.
- 7 Q Really because she was in the bathroom when
- 8 her friend was the victim of battery in this bar she was
- 9 just frustrated would that be a fair statement?
- 10 A I don't know the person. I don't know why
- 11 she was acting.
- 12 Q In any event after she was you say she was
- 13 obstructing did you charge her with obstructing?
- 14 A No.
- 15 Q Did she ever give you a false name?
- 16 A No.
- 17 Q No, not in that regard. Okay. After you -
- 18 after she wouldn't after she kept interfering with
- 19 this investigation insisting that you arrest someone
- 20 for what happened to her friend what happened next?
- 21 A She charged at Officer Brendal.
- 22 Q It's your testimony she just charged at him,
- 23 is that your testimony, Officer?
- A (Nodding.)

- 1 Q That's the first time she displayed any
- 2 violence or any touching of you or Officer Brendal?
- 3 A That I seen.
- 4 Q I think you told us Officer Brendal he held
- 5 his breath?
- 6 A Yes.
- 7 Q She didn't knock him down?
- 8 A She knocked him backwards.
- 9 Q How far did she knock him backwards?
- 10 A I don't know. I stepped backwards.
- 11 Q What portion of her body came in contact
- 12 with which portion of Officer Brendal's body?
- 13 A Her hands out this way I saw from corner of
- 14 my eye she went at him like this leaning like talking
- 15 to the victim.
- 16 Q You saw her hands in front of her chest, is
- 17 that what you first saw?
- 18 % A Yes.
- 19 Q At that time were you specifically keeping
- 20 an eye what Officer Brendal and my client were doing
- 21 or talking were you focused on other things going on
- 22 outside of this bar?
- 23 A Little bit of both. I was here, there, trying
- 24 to ask other people trying to get information.

- 1 Q You were trying watching crowd control you
- 2 didn't know another altercation was going to erupt?
- 3 A Yes.
- 4 Q Only you and Officer Brendal?
- 5 A There was couple part-time officers came up
- on the scene, ambulance, another town came over
- 7 because the other bar next store started empty out.
- 8 Q 2:00 o'clock in the morning after been an
- 9 altercation you assume people were drinking could have
- 10 been a volatile situation?
- 11 A Yes.
- 12 Q That is really primary concern?
- 13 A Yes.
- 14 Q In all honesty what happened between my
- 15 client and Officer Brendal you only caught out of the
- 16 corner of your eye, right?
- 17 A Stands to my right, yes.
- 18 Q What Officer Brendal and her were doing before
- 19 you saw her arms in front of you, you can't honestly
- 20 testify to, can you?
- 21 A What Officer Brendal -.
- 22 You said you saw her like this make contact
- 23 with Officer Brendal out of the corner of your eye, asking
- you before that you were obviously doing other things?

- 1 A She walked in front of me when she did she
- 2 went past me.
- 3 Q Once again Officer Brendal has his vest on?
- 4 A I believe so.
- 5 O You testified he had a vest on?
- A I'm sure he would normally wear it. I didn't
- 7 check him.
- 8 Q Because of her screaming and her being
- 9 upset regarding her friend being battered insists on
- 10 someone being arrested you at that time determined
- 11 that the proper thing to do calm this woman down,
- 12 pepper spray her?
- 13 A She refused -.
- 14 THE COURT: She was what?
- THE WITNESS: She refused my command when I told
- 16 her to stop when she was going at Officer Brendal again
- 17. I warned her.
- 18 THE COURT: Earlier she had raised her arm she
- 19 didn't?
- THE WITNESS: She backed up he backed up she went
- 21 at him again with arms raised again.
- MR. BERNS: O Aside from initial contact you
- 23 testified to maybe I'm unclear?
- 24 THE COURT: There is two incidents the Court

- 1 understands two incidents. The one incident she did
- 2 make physical contact with Officer Brendal. The second
- 3 incident sparked the officer to pepper spray that's
- 4 what I understand.
- 5 MR. BERNS: Just trying to clarify.
- 6 THE COURT: That's fine.
- 7 MR. BERNS: Q Whether there was any other physical
- 8 contact he talked about hands being up may I inquire?
- 9 THE COURT: I understand. You may inquire.
- 10 MR. BERNS: Q After this initial alleged pushing
- 11 you saw any other time did she batter allegedly batter
- 12 Officer Brendal or just have hands up acting in
- 13 uncontrolled manner something else?
- 14 A She didn't batter a second time, no.
- 15 Q There was never any other batteries committed
- on Officer Brendal so we're clear?
- 17 A Not that I know of. First one all I know.
- 18 . O When you arrived there if there was you would
- 19 have seen it?
- 20 A If there was another incident.
- 21 Q Just because you thought this woman was not
- 22 listening to verbal commands you pepper sprayed then
- 23 took into custody basically came un-eventful at that
- 24 time?

- 1 A To me appeared she was going to commit a second
- 2 battery that's why I pepper sprayed.
- 3 O She didn't?
- 4 A Because I pepper sprayed.
- 5 Q So, we can rap up here you subdued her when
- 6 she calmed down at the station she thought about what
- 7 had taken place you're indicating she became a much
- 8 calmer nicer person?
- 9 A Yes.
- 10 MR. BERNS: Nothing further. One question.
- 11 Q Besides Officer Brendal taking a step back
- 12 did he ever need medical attention for that push
- 13 alleged push?
- 14 A You have to ask him.
- 15 Q Are you aware of that?
- A All I know he came back from a month ago
- 17 from a shoulder injury. I don't know if he has any
- 18 more or not.
- 19 Q Are you aware of any medical testimony says
- 20 shoulder injury related to push?
- 21 A No.
- 23 aware that Officer Brendal was injured because of this
- 24 push?

- 1 A I don't know.
- 2 Q Cause you don't know are you aware whether
- 3 Officer Brendal required any medical attention aside
- 4 from cross contamination from your pepper spray that
- 5 immediate area for the push?
- 6 A No.
- 7 MR. BERNS: Thank you.
- 8 THE COURT: Your witness, Mr. Russell.
- 9 RE-CROSS EXAMINATION
- BY MR. RUSSELL:
- 11 Q Did you see the defendant make physical
- 12 contact with Officer Brendal?
- 13 A Yes, I did.
- MR. RUSSELL: That's all I have.
- 15 THE COURT: Okay. Anything further?
- MR. BERNS: Nothing.
- 17 THE COURT: Call your next witness.
- 18 MR. RUSSELL: Can I see the complaint?
- 19 THE COURT: Sure. Brief recess.
- 20 (Whereupon a brief recess was taken.)
- 21 THE COURT: Recall the trial.
- 22 OFFICER BRENDAL,
- the witness herein, having been first duly
- sworn, was examined and testified as follows:

DIRECT EXAMINATION 1 BY MR. RUSSELL: 2 Officer, state your name, spell your last 3 name for the Court Reporter, badge number and department? 4 5 Ά Officer Brian Brendal, B-r-e-n-d-a-l, Star 91, Summit Police Department. 6 7 How long have you been employed by Summit 8 Police Department? Over 10 years. 9 Α Were you so employed by Summit Police Department 10 Q 11 on May 21, 2006, approximately 2:00 a.m.? 12 Α Yes. What were you working that night? 13 14 Patrol. Α Did you have occasion to go to 6303 S Archer? 15 16 Α Yes. 17 What did you go there for? Q 18 Α For fight call. And when you arrived there did you speak with 19 Q 20 anybody? 21 I spoke with a male subject. Α Do you remember his name? 22 Q No, I don't. 23 Α

And why were you speaking with him?

- 1 A He appeared to be the victim of a battery.
- 2 I was trying to obtain information from him.
- 3 Q Was anyone else present when you were doing
- 4 this?
- 5 A There was a lot of people around probably
- 6 50 people outside of the bar.
- 7 Q Any of your fellow officers arrive with you?
- 8 A Yes, they did.
- 9 0 Who is that?
- 10 A Officer Michael Dubinka and other responding
- 11 units.
- 12 Q While you were speaking with the victim of
- 13 this battery was there anyone else present?
- 14 A Yes.
- Q Who was present?
- 16 A The defendant.
- Q Can you please point to the person who was
- 18 present that you referred to as defendant?
- 19 MR. BERNS: In-court I.D.
- 20 THE COURT: Stipulate to in-court identification
- 21 of the defendant.
- MR. RUSSELL: Q When you were speaking with the
- victim what if anything did the defendant do?
- 24 A I was approaching by the defendant and she

- 1 was saying that I wasn't doing anything that I should
- 2 arrest the people. Then I asked the defendant if she
- 3 saw what happened she then told me no, I didn't see
- 4 it I was in the bathroom at the time.
- 5 Q Then what did you say?
- 6 A Then I said I need you to step back I need to
- 7 get information. I don't need to talk to you then she
- 8 began swearing and yelling at me some more and then I
- 9 started to try to get more information from the
- 10 victim of the apparent victim of this battery.
- 11 Q After you tried to get more information from
- 12 the victim of the battery what, if anything, did the
- 13 defendant do?
- 14 A I was shoved by the defendant.
- 15 Q When you were shoved can you describe how far
- 16 . away the defendant was from you when you were initially
- 17 starting speaking with her?
- 18 A One more time.
- 19 Q How far away was the defendant when she first
- 20 started swearing at you?
- 21 A About two feet.
- 22 Q And were you standing or were you kneeling?
- 23 A I was standing.
- Q When you were shoved describe how the

- 1 defendant shoved you?
- 2 A I was my attention was focused apparent
- 3 victim of the battery and then I was shoved in the
- 4 upper chest and I stepped back about three feet
- 5 because took me by surprise then I informed she was
- 6 under arrest.
- 7 Q And when she shoved you how did that feel?
- 8 A Offensive.
- 9 Q Offensive was your word?
- 10 A Yes.
- 11 Q Did cause you any pain?
- 12 A No.
- 13 Q After she shoved you what if anything happened?
- 14 A I informed her she was under arrest that she
- 15 still proceeded to yell and scream at me then
- 16 Officer Dubinka said do what he says you're under arrest.
- 17 She began to come at me again and then Officer Dubinka
- 18 sprayed her with pepper spray.
- 19 Q After she was sprayed with pepper spray what
- 20 happened?
- 21 A I also had some of the affects of the pepper
- 22 spray -.
- 23 MR. BERNS: I would just state at this point
- 24 and time unless testimony going to differ from the

- 1 first officer this is immaterial.
- 2 THE COURT: Sustained.
- 3 MR. BERNS: Unless allegations of another
- 4 battery.
- 5 THE COURT: I agree. Sustained.
- 6 MR. RUSSELL: There is admission -.
- 7 MR. BERNS: Stipulate testimony being consists
- 8 with first officer.
- 9 MR. RUSSELL: That's fine.
- 10 THE COURT: Okay. Nothing further?
- 11 MR. RUSSELL: No.
- MR. BERNS: Cross, do you want us to approach?
- 13 THE COURT: Yes, come on.
- (Whereupon a discussion was had off the
- 15 Record.)
- MR. BERNS: Judge, at this -.
- 17 THE COURT: You don't want to cross examine?
- 18 MR. BERNS: Not at this time. I'll reserve
- 19 the right.
- 20 MR. RUSSELL: State rests.
- 21 THE COURT: Motion?
- MR. BERNS: Judge, at this time make a motion
- 23 for a directed finding. Complaint on it's face
- 24 alleges bodily harm as a result of alleged shoving

- 1 batter, however, the court looks at it. The officer
- 2 I got to admit this is credible, honest officer,
- 3 Judge. I commend him for just telling the truth if
- 4 that's what happened. He said he wasn't injured in
- 5 response to counsel's question says he was assaulted.
- 6 There is a way to charge that.
- 7 THE COURT: I understand. Anything, Mr. Russell?
- 8 MR. RUSSELL: Judge, you did hear the testimony.
- 9 THE COURT: There is no question that this
- 10 lady committed a battery not the battery described
- 11 from what I heard so far. There is no question in
- 12 Court's mind all the elements of battery not under
- 13 Section 5123 which caused bodily harm because Officer
- 14 Brendal being very honest as he is says he was
- 15 offended. He was not hurt. Felt no pain. Right there
- diminishes anything in the complaint that says bodily
- 17 harm. Had it said touch of insulting nature would be
- 18 a different story. That's not statutory provision
- 19 complaint written. No question if in Court's mind the
- 20 defendant caused a touching of insulting nature. She
- 21 should have at this point there be enough evidence to
- 22 find her guilty of that battery and I think the
- 23 officer was probably justified pepper spraying her when
- 24 she raised her hands. Evidently, was going to come
