## ORDER OF JUDGMENT

This matter having come before the Court on plaintiffs' Motion for Entry of Final Judgment, IT IS HEREBY ORDERED:

- 1. Within 30 days of final judgment, Encore shall pay directly to plaintiffs \$8,000 in statutory damages for refusal to rescind the June, 2004, loan and \$31,223.72 for rescission of the June 30, 2004 loan;
- 2. Within 30 days of final judgment, HSBC shall pay directly to plaintiffs \$4,000 in statutory damages for refusal to rescind the January 7, 2005, loan;
- 3. Within 45 days of final judgment, plaintiffs shall close on their refinance transaction with Neighborhood Lending Services, Inc. ("NLS"), and tender \$417,753.15 to HSBC, the present holder of plaintiffs' 2005 loan; HSBC shall accept this amount as the full and complete payoff of the 2005 loan;
- 4. Within 7 days following plaintiffs' payoff to HSBC, HSBC shall record a release of its mortgage on plaintiffs' property with the Office of the Cook County Recorder of Deeds; and

5. All remaining counts are dismissed with prejudice as to all defendants, as requested by plaintiffs.
