## JUDGMENT ORDER

Default Judgment is hereby entered in favor of the Plaintiffs and against Defendant UNITED MECHANICAL CONTRACTORS INC. ("UNITED") as follows:

- Judgment is hereby entered in favor of Plaintiffs and against Defendant UNITED in 1. the amount of \$51,691.80;
- Defendant UNITED, through its President, Rodney Mumphrey, is ordered to submit 2. Contribution Reports for the months of December of 2008, and January, February and March of 2009 to Plaintiffs' attorneys within five (5) days of being served with a copy of this Order;
- Defendant UNITED, through its President, Rodney Mumphrey, is ordered to submit 3. 401(k) Contribution Reports for the months of November and December of 2008,



and January, February and March of 2009 to Plaintiffs' attorneys within five (5) days of being served with a copy of this Order;

- 4. Judgment is entered in favor of Plaintiffs and against Defendant UNITED for whatever Contributions, liquidated damages and interest is shown to be due and owing for the months of December of 2008 and January, February and March of 2009 in addition to the amount reference above.
- 5. Judgment is entered in favor of Plaintiffs and against Defendant UNITED for whatever 401(k) Contributions, 401(k) liquidated damages, and 401(k) interest is shown to be due and owing in the 401(k) Contribution Reports for the months of November and December of 2008 and January, February and March of 2009.
- 6. Plaintiffs shall have leave to file a Motion for Entry of a Final Judgment Order against Defendant UNITED once the missing Contribution Reports are submitted and full damages are computed;
- Defendant UNITED is ordered to pay all of Plaintiffs' reasonable attorney's fees and 7. costs pursuant to the Collective Bargaining Agreement, Trust Agreements, 29 U.S.C. § 1132(g)(2)(D) and the Agreed Order and Settlement Agreement; and
- That the Plaintiffs have such other relief as the Court may deem just and equitable all 8. at Defendant UNITED'S cost, pursuant to 29 U.S.C. § 1132(g)(2)(E).
