The Defendant executed an Agreement with the Chicago Regional Council of Carpenters, successor to the Chicago and Northeast Illinois Regional Council of Carpenters whereby it agreed to be bound by the provisions of a Collective Bargaining Agreement and to all Collective Bargaining Agreements subsequently negotiated.
- 3. Pursuant to the provisions of the Collective Bargaining Agreement, signatory employers are required to submit monthly reports to the Union detailing all hours worked by its employees covered under the Agreement.

4. An audit was conducted of the books and records submitted by the Defendant for the period of October 2006 through March 31, 2009 which reveals that Defendant owes \$138.833.50 in wages and \$9,071.42 in unpaid dues to the Plaintiff for a total amount of \$147,904.92. A breakdown of amounts owed is attached.
