- (3) Defendant, OTT, individually, was given notice of Summons on April 8, 2009 by substitute service and on April 29, 2009, May 6, 2009 and May 13, 2009 by publication, and his appearance or responsive pleading was due on May 25, 2009;
- (4) Defendant EMILY, an Illinois corporation, was given notice of Summons on April 29, 2009, May 6, 2009 and May 13, 2009 by publication, its appearance or responsive pleading was due on May 25, 2009;
- (5) The above-named Defendants failed to appear, answer or otherwise plead;
- (6) The above-named Defendants are in default such that judgment is entered against them and the allegations in Ford Credit's Verified Complaint are deemed to be true as to said Defendants;
- (7) Ford Credit is hereby awarded judgment in the amount of \$1,798,080.01 against Defendants Emily, Inc and Ott, jointly severally, with pre-judgment interest (at 5% per annum) in the amount of \$40,641.15, plus interest accruing thereafter at the legal post-judgment rate.
