DECLARATION OF CAMERON M. NELSON

1. My name is Cameron M. Nelson. I am an associate with Greenberg Traurig, LLP and counsel to Google Inc. in the above-captioned case.

2. On June 23, 2010, I received an email from Plaintiffs' counsel alleging that they had uncovered 811 "broken" files in Google's document production and demanding that "usable" copies of these files be produced. (Ex. 1.)

3. I investigated Plaintiffs' counsel's complaints and generated a spreadsheet of additional information relating to the purportedly "broken" files. I noted that over 600 of the files had file sizes of less than 32 KB, which for most files (i.e., .pdf files) indicates that the file is a mere fragment and contains no useful information. While I did not attempt to open each and every one of these fragments, I attempted to open several to confirm my belief that they were in fact fragments and not openable.

4. I further noted that the remainder of the files that were not file fragments were generally of file types that are not ordinarily produced in litigation. For example, TrueType Font files (.ttf files) are system files which define how fonts are to be rendered. I have investigated the reasons these files were included in the production by the outside vendors who were involved

in the document production, and determined that these files were all likely included because of the presence of some keyword (e.g., “Android”) in the file name or file path.

5. After reviewing the purported “broken” files I provided Plaintiffs’ counsel with the results of our analysis. I also provided Plaintiffs’ counsel with five files that, after some manipulation, we were able to open. (Ex. 2.) I asked Plaintiffs’ counsel to identify whether there were any other specific files they believed might contain relevant information. I believe the spreadsheet I provided Plaintiffs’ counsel readily demonstrates that the remaining files do not contain any information even potentially relevant to this case.

6. Rather than review the data I had provided, Plaintiffs’ counsel instead insisted on receiving all 811 files, in “usable” format. (Ex. 3.) I do not have readily available means of reviewing the programming code or system files. Nevertheless, we provided native copies of all 811 files to Plaintiffs’ counsel. (Ex. 4.) A CD with the files on it was sent to Plaintiffs’ counsel by messenger on .

I declare under penalty of perjury under the laws of the United States that the foregoing information is true and correct to the best of my knowledge, information and belief.

Mr. Haarlow,

Attached please find a spreadsheet describing the file name, file extension, and file size of each of the 811 documents you have inquired about.

As you can see, your statement that these documents are "apparently incomplete or broken" is well off the mark. Many of these files are documents which are not viewable by traditional means -- they include Photoshop files, JavaScript files, RSA security key files, Flash files, and TrueType Font files, operating system files and programming code. There is nothing "broken" or "incomplete" about these files -- they are simply not readily convertible to .TIFF or .PDF format. Moreover, the nature of these files readily establishes that they do not contain relevant information. For example, TrueType Font files clearly have no relationship to any facts at issue in this case.

The vast majority of these 811 files are also simply empty or corrupt files with no discernable information in them -- 643 of these files are less than 32 KB in size, and the vast majority of those are 1 KB or less. We have spot-checked a number of these small files and all of those that we checked were un-openable.

There are two .pdf files on the list that are larger than 1 KB. We are able to open those files. It appears that their content is a non-standard rendering set which is why they did not readily convert to .tiff format. Copies of those files are attached to this email for your review. Please treat these files as "Highly Confidential - Attorney's Eyes Only." We will provide you with formal production copies shortly.

There were also three files on the list described as "MSMAIL" files. We were not initially able to open these files, but on further investigation we determined that these files could be opened if their extensions were changed to .html. Those files are also attached for your review. Please also treat these files as "Highly Confidential - Attorney's Eyes Only." We will provide you with formal production copies shortly.

These five files are the only files that appear to be of the sort that would normally be included a document production. We believe the other files are by definition not relevant because of their file type (technical files not possibly relating to facts at issue) or because they are corrupt (file size smaller thane 32 KB). Accordingly, we request that you review the attached spreadsheet and let us know if there are any additional native files you believe you need to review, or alternatively confirm that you do not need the remainder of these files.

Cameron - By reviewing and producing the 811 documents you conceded that they are within the scope of discovery dictated by Rule 26(b)(1), responsive to our document requests and not privileged or otherwise immune from discovery. You also concede -- and we agree -- that the 811 documents are "not readily convertible to .TIFF or .PDF format," i.e. not reasonably usable. However, Rule 34(b)(2)(E)(ii) requires you to produce all electronically stored information "in a form or forms in which it is ordinarily maintained or in a reasonably usable form or forms." Your contention after the fact -- which appears largely or entirely based on the technical specifications of these files rather than their substance -- that we should not concern ourselves with the vast majority of these documents because the "nature of these files readily establishes they do not contain relevant information" or they are "not of the sort that would normally be included in a document production" does not excuse your failure to comply with Rule 34(b)(2)(E)(ii) and does not explain why you considered them responsive and produced them in the first place. Accordingly, please provide all 811 files in a reasonably usable format.

Mr. Haarlow,

Attached please find a spreadsheet describing the file name, file extension, and file size of each of the 811 documents you have inquired about.

As you can see, your statement that these documents are "apparently incomplete or broken" is well off the mark. Many of these files are documents which are not viewable by traditional means -- they include Photoshop files, JavaScript files, RSA security key files, Flash files, and TrueType Font files, operating system files and programming code. There is nothing "broken" or "incomplete" about these files -- they are simply not readily convertible to .TIFF or .PDF format. Moreover, the nature of these files readily establishes that they do not contain relevant information. For example, TrueType Font files clearly have no relationship to any facts at issue in this case.

The vast majority of these 811 files are also simply empty or corrupt files with no discernable information in them -- 643 of these files are less than 32 KB in size, and the vast majority of those are 1 KB or less. We have spot-checked a number of these small files and all of those that we checked were un-openable.

There are two .pdf files on the list that are larger than 1 KB. We are able to open those files. It appears that their content is a non-standard rendering set which is why they did not readily convert to .tiff format. Copies of those files are attached to this email for your review. Please treat these files as "Highly Confidential - Attorney's Eyes Only." We will provide you with formal production copies shortly.

There were also three files on the list described as "MSMAIL" files. We were not initially able to open these files, but on further investigation we determined that these files could be opened if their extensions were changed to .html. Those files are also attached for your review. Please also treat these files as "Highly Confidential - Attorney's Eyes Only." We will provide you with formal production copies shortly.

These five files are the only files that appear to be of the sort that would normally be included a document production. We believe the other files are by definition not relevant because of their file type (technical files not possibly relating to facts at issue) or because they are corrupt (file size smaller than 32 KB). Accordingly, we request that you review the attached spreadsheet and let us know if there are any additional native files you believe you need to review, or alternatively confirm that you do not need the remainder of these files.

Dear John:

This is in response to your email of July 9, 2010, regarding a number of electronic files that were not readily convertible to .tiff format.

As we have told you, we conducted a second manual review of these files, and we forwarded to you those files we were able to open. The remainder of these files are simply unopenable by normal means. Based on their file extensions and file sizes, which we have also provided to you, many of them appear to be nothing more than programming code, system files, and corrupt or incomplete files. Over 600 of these files are too small to contain any useful data.

Moreover, your argument that "by reviewing and producing" these files we "conceded" they are within the scope of discovery is wrong. As we have told you, we cannot review the files, because we cannot open them. They were likely included in the production, because they respond to some keyword used to cull the initial production -- for example, a number of the files have the word "android" in their filename. Further, your request to receive these files in a "reasonable usable format" is impossible to comply with as we've told you we cannot open them.

Nevertheless, you are welcome to spend as much time as you wish scouring "TrueTypeFont" system files, corrupt file fragments, and any other files included in this list. Enclosed please find a CD containing all 811 files. Since we cannot open these files, all are designated "Highly Confidential - Attorneys' Eyes Only" under the Protective Order. Furthermore, we are producing them without waiving any applicable privilege or immunity.

John,

We disagree with Plaintiffs' position regarding Google's objections to Plaintiffs' overbroad Rule 30(b)(6) deposition notice. Plaintiffs' Rule 30(b)(6) Notice contains 32 categories; Google has agreed to provide a witness prepared to testify on its behalf for all of these categories. Google provided you timely written objections on June 29th, and has scheduled two Rule 30(b)(6) witnesses to address the majority of the information Plaintiffs seek.

As there are subjects within the categories of information that Google has objected to, and for which Google does not currently intend to produce a Rule 30(b)(6) witness, Google is fully within its rights to state objections to Plaintiffs' Rule 30(b)(6) categories. A Rule 30(b)(6) Notice is not a unilateral edict, and that some of Plaintiffs' Rule 30(b)(6) categories seek irrelevant information is a perfectly appropriate basis for objection. If Plaintiffs disagree with Google's objections, the appropriate course would be for Plaintiffs to provide further information as to why they believe the information sought through these categories is relevant, or otherwise explain why Plaintiffs believe they are entitled to overcome Google's objections. If the parties are unable to reach agreement on the merits, then assistance from the Court may be necessary. At this point, however, we have not received any substantive response on the merits of our objections.

Your insistence that you will be "questioning Google's 30(b)(6) witnesses on all subjects" is somewhat nonsensical. First, each witness being produced is only being produced as a Rule 30(b)(6) witness on the specific categories we have identified. While you are welcome to ask each of Google's Rule 30(b)(6) witnesses questions in their individual capacity, it is inappropriate to suggest that both witnesses must be prepared to answer questions on all categories.

Further, your suggestion that you will seek "fees and expenses" associated with further Rule 30(b)(6) testimony is also misplaced. Even if you were able to persuade us that the objected-to categories are discoverable, that does not mean that Google's witness designated for those categories would be the same as the two currently-designated Rule 30(b)(6) witnesses. In other words, even if Google had not objected to these Rule 30(b)(6) categories, a third trip to California to depose a third Rule 30(b)(6) witness may well have been necessary anyway.

We also note that you appear to have vastly different interpretations of the requirements of Rule 30(b)(6) when applied to witnesses associated with Plaintiffs. During the yesterday's deposition of Eide & Eide, you objected and insisted that the Rule 30(b)(6) witness need only testify as to what is in the "recollection" of the corporation -- as obtained by speaking with other employees, and that Rule 30(b)(6) witnesses have no duty to learn facts as reflected in documents in the corporation's possession. Indeed, Mr. Eide had not reviewed a substantial number of documents within his document production, was not prepared to answer even basic questions such as the years he prepared tax returns for Plaintiffs, and refused (in view of your objection) to answer question about seemingly undisputed facts.

Regardless, Google's Rule 30(b)(6) witnesses will be appropriately prepared to answer questions on the categories for which they have been designated. Moreover, they will answer any further questions you might have based on the limits of the personal knowledge they might possess.

If you wish to discuss the merits of our objections to Plaintiffs' 30(b)(6) notice, we remain available to do so.

Herb,

This concerns Google's Objections To Plaintiffs' Notice Of Rule 30(b)(6) Deposition To Google, Inc. ("Objections"). Google cannot refuse to give deposition testimony, except: (1) when necessary to preserve a privilege; (2) to enforce a limitation ordered by the court; (3) or to present a motion under Rule 30(d)(3). Accordingly, your assertion that Google will refuse to tender a witness to testify regarding various subjects on "relevance" grounds is improper. (E.g., Objection, Nos. 6, 9, 17, 18-22, 25, 26.) Relevance objections may, but need not, be asserted at a deposition. Either way, such objections are reserved under Rule 32(d)(3)(A). The Rules of Procedure do not, however, permit Google to refuse to provide deposition testimony on relevance grounds without a court order to that effect.

So it is clear, notwithstanding your improper objections, we will be questioning Google's 30(b)(6) witnesses on all subjects set forth in Plaintiffs' 30(b)(6) notice. If Google refuses to answer any questions on grounds other than privilege – including relevance – without seeking and obtaining a protective order in advance, and, as a result, we are compelled to make an extra trip to California or retake part or all of a deposition, we will seek to recover all resulting fees and expenses.
