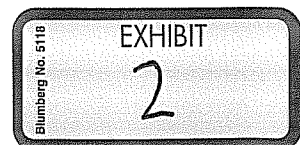

ORDER FOR DEFAULT JUDGMENT

Default Judgment is hereby entered in favor of Plaintiffs and against Defendant WAGNER HEATING AND VENTILATING CO. ("WAGNER") as follows:

1. Default Judgment is entered in favor of Plaintiffs and against Defendant WAGNER in the amount of \$6,873.67 for all known contributions, liquidated damages and interest;
2. Defendant WAGNER, through its Principal Officer, Robert R. Freiny, is ordered to submit Contribution Reports for the months of November and December of 2008, and January, February, March and April of 2009, within five (5) days from being served with this Default Order;



3. Judgment is entered in favor of Plaintiffs and against Defendant WAGNER for any and all contributions, liquidated damages and interest charges that are shown to be due and owing on the missing Contribution Reports for the months of November and December of 2008 and January, February, March and April of 2009 in addition to the known amounts referenced in paragraph 1 above;
4. Defendant WAGNER, through its Principal Officer, Robert R. Freiny, is ordered to submit 401(k) Contribution Reports for the months of November and December of 2008, and January, February, March and April of 2009 within five (5) days of being served with this Default Order;
5. Judgment is entered in favor of Plaintiffs and against Defendant WAGNER for any and all 401(k) contributions, 401(k) liquidated damages and 401(k) interest charges that are shown to be due and owing on the missing 401(k) Contribution Reports for the months of November and December of 2008 and January, February, March and April of 2009 in addition to the known amounts referenced in paragraph 1 above;
6. That Defendant WAGNER is ordered to pay all of the reasonable attorney's fees and costs incurred by the Plaintiffs in the course of bringing this suit pursuant to the Collective Bargaining Agreement, Trust Agreements and 29 U.S.C. §1132(g)(2)(D);
7. That Plaintiffs have such other and further relief as the Court may deem just and equitable all at the Defendant WAGNER'S cost, pursuant to 29 U.S.C. §1132(g)(2)(E).
