

 - 3. I believe Saab Downers Grove assigned the contract for the purchase of the

BMW to Patelco Credit Union. The reason for my belief is that my son, Michael Walczak, spoke with Patelco Credit Union who informed him of this. See Declaration of Michael Walczak.
