## DEFAULT ORDER

An Order of Default is hereby entered in favor of Plaintiffs and against Defendant COLETTE & ANO PLUMBING COMPANY, INC. ("COLETTE") as follows:

- 1. Default is entered in favor of Plaintiffs and against Defendant COLETTE in the amount of \$5,712.99 for contributions owed for the month of August of 2009;
- 2. Defendant COLETTE is hereby Ordered to submit Contribution Reports for the months of September and October of 2009 within five (5) days from the date of being served with a copy of the Default Order;

- Judgment is entered in favor of Plaintiffs and against Defendant COLETTE for all contributions found to be due and owing for the months of September and October of 2009;
- 4. Judgment is entered in favor of Plaintiffs and against Defendant COLETTE for all liquidated damages owed for the time period of June through October of 2009;
- 5. Judgment is entered in favor of Plaintiffs and against Defendant COLETTE for all of Plaintiffs' reasonable attorney's fees and costs pursuant to the terms of the Collective Bargaining Agreement, Trust Agreements and 29 U.S.C. §1132(g)(2)(D);
- 6. Plaintiffs are granted leave to file for Final Judgment once the total aggregate amount owed to Plaintiffs from Defendant COLETTE can be determined;
- 7. That the Plaintiffs have such other relief as the Court may deem just and equitable all at Defendant's cost, pursuant to 29 U.S.C. § 1132(g)(2)(E).
