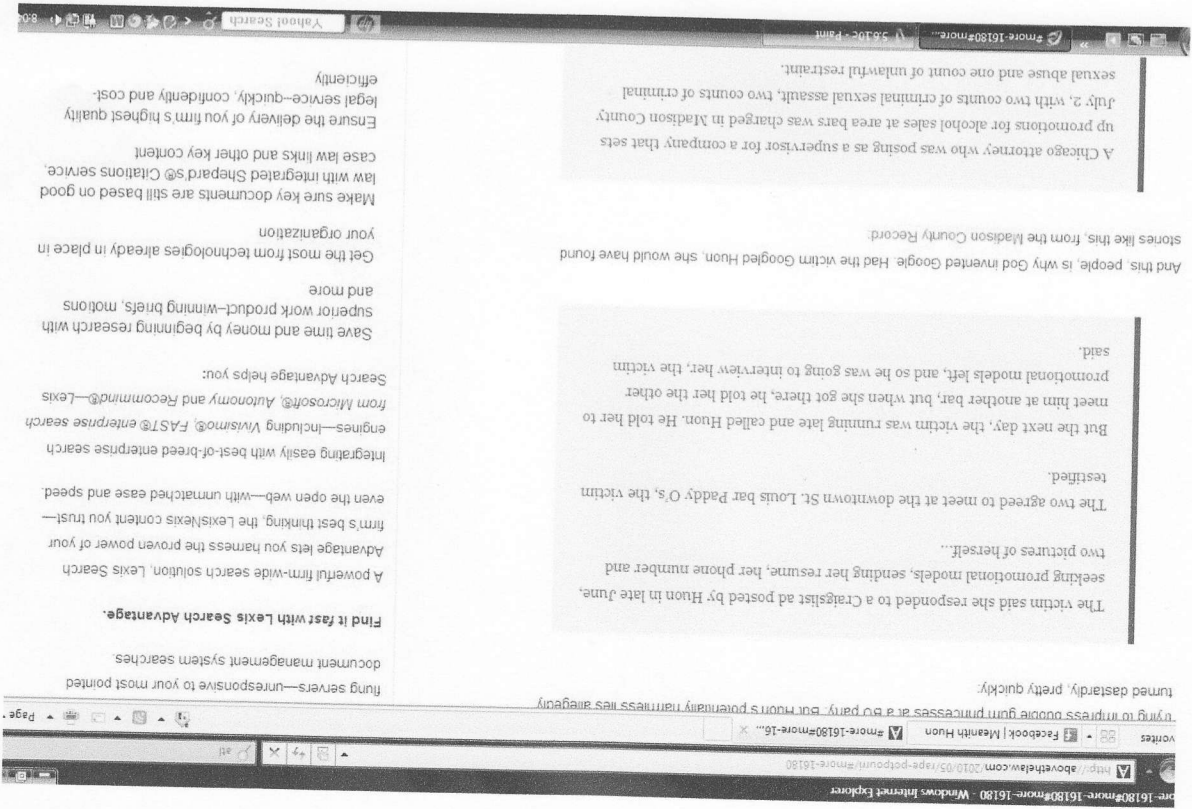

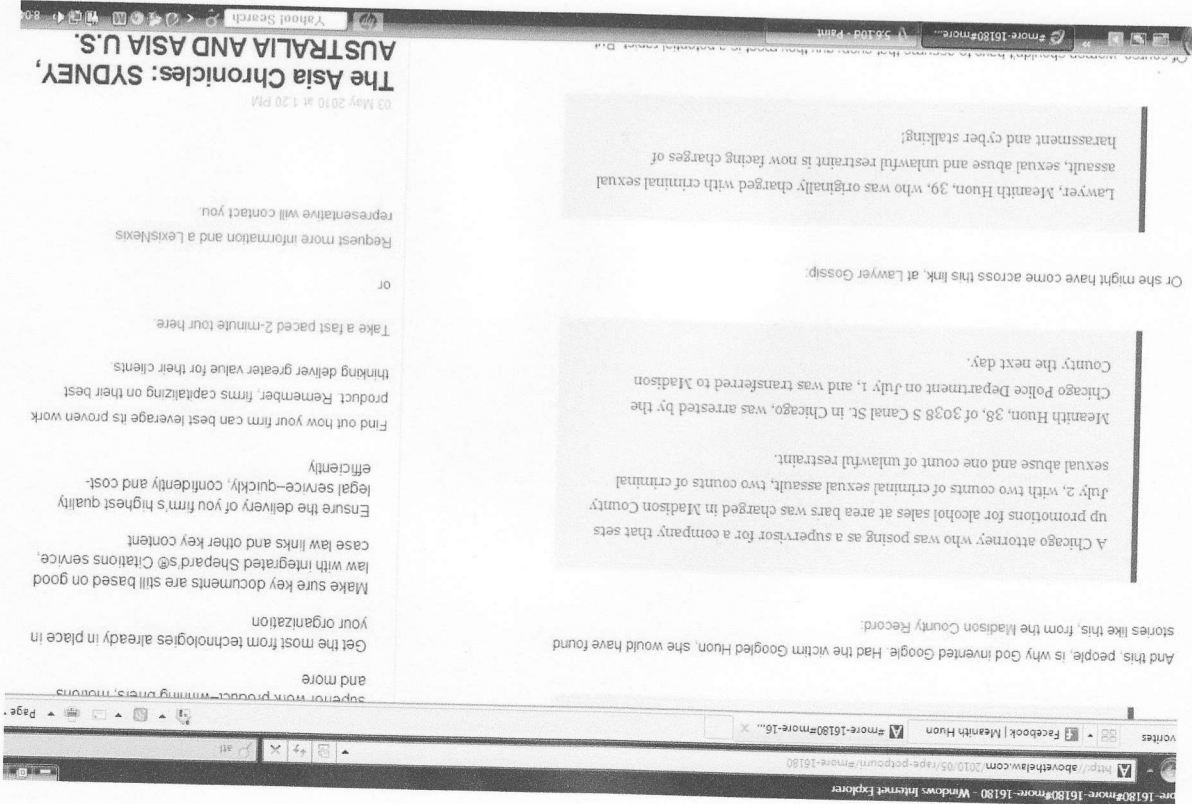


The woman agreed, but told Huan she didn't have enough gas in her car, so she went with him, she said.
