DWARDSVILLE - A Chicago lawyer was charged Wednesday vith five felonies for allegedly assaulting a woman while driving is car on Interstate 55.

Meanith Huon, 38, was charged in Madison County Circuit Court with two counts of criminal sexual assault, two counts of

criminal sexual abuse and a count of unlawful restraint Authorities said Huon allegedly lured a woman into a car he

vas driving Sunday night, then committed the alleged sexual cts on her while driving on I-55.

le allegedly forced the woman to perform a sex act on him. ondled her breast and genitals, and refused to let her out of he car while driving on the interstate into Madison County.

She told police she was able to jump out of the car as Huon

vas making a turn and had slowed almost to a stop. She suffered abrasions but got to a home in the 1200 block of New Douglas Road, New Douglas, and asked the residents to call olice.

Madison County sheriff's deputies said the incident began as a esult of the victim looking for a job on an Internet blog. After alking to Huon over the telephone and getting the impression hat the job was in promoting alcohol sales in area taverns, she net Huon, who identified himself as "John," in downtown St.

ouis. after she got into the car, he told her that other women doing

he promotional work for him were working at Pop's Saloon in sauget. He offered to drive the victim there to check on the ype of night the women were having.

lowever, he did not turn off at the exit to Sauget, but allegedly exually abused and assaulted his passenger while driving on ne interstate.

after the woman jumped from the car, Huon drove from the rea, deputies said.

t. Brad Wells of the Madison County Sheriff's Department said ome information about Huon's identity was obtained by ooking at images from security cameras in downtown St. ouis. Other information was obtained from communications ecords.


