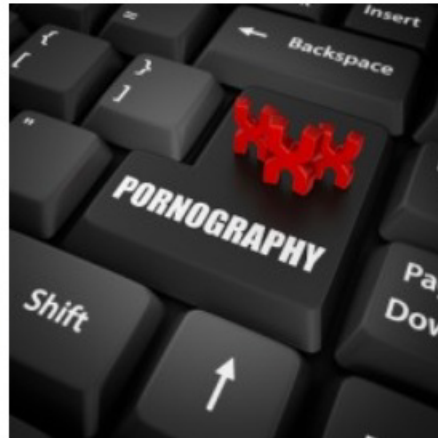
It's a tale as old as time, and perhaps — if you were desperate enough — you've even experienced it yourself.

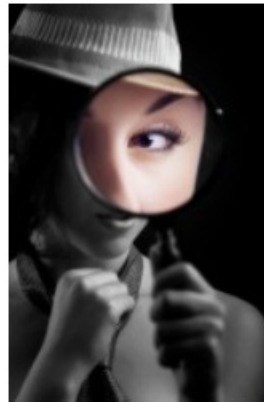

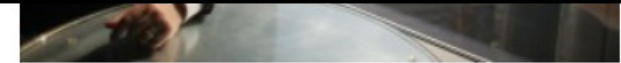
