process server has identified that the person she served is Jan Moody after looking at a copy of

Jan Moody's driver's license and has identified the property where she served Jan Moody. (See

Exhibit 3).

5. The Plaintiff seeks a default judgment and he reincorporates his previous motion

for default as if set forth fully herein.

WHEREFORE Plaintiff prays that this court enter a default judgment against Jan Moody

and for further relief that is just and equitable in the circumstances.


