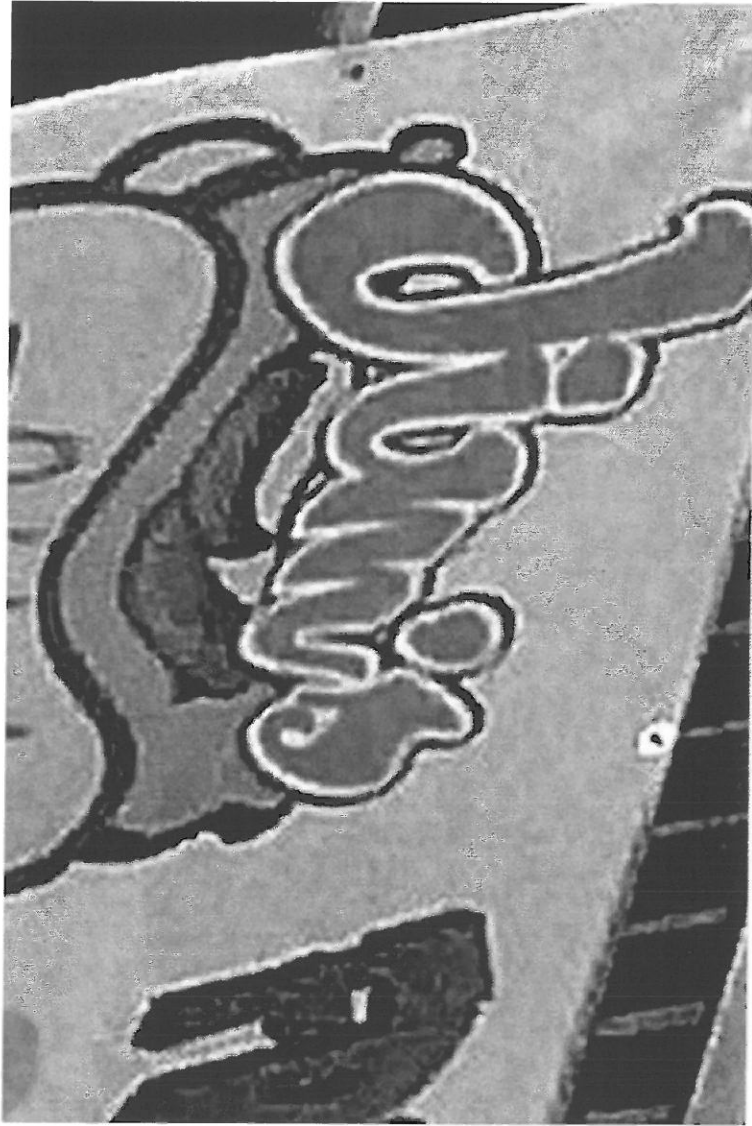

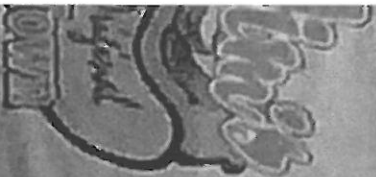


Original MAXWELL STREET POL
