I'm sure he'd love to have a hold of Larry Bird's neck right now. Dr. J is so broke he's selling some of his coolest personal items collected during a career as one of the most dominant players in NBA history. And sure, while the Dr. didn't play in an era of financial excesses like the players of the current era, is it unreasonable to assume he would have some money in the bank?



According to an article in the Atlanta Journal Constitution, Dr. J is selling some of his most cherished possessions in an effort to make some money and pay of a loan. These items include:

- 2 ABA Championship rings
- 1983 NBA championship ring
- 50 Greatest Players Ring
- MVP Trophies
- All Star Game MVP Trophies

And that's the short list of items that Dr. J will need to part with in order to pay his debt. But Dr. J's plight isn't singular or unheard of- 60% of NBA players declare bankruptcy within five years of retirement.

But other NBA players can relate. Former NBA all-star Kenny Anderson's certainly can. Anderson was spending 41,000 dollars a month between child support for his kids and paying for his mother's house when he filed for bankruptcy in 2005. During an NBA career in which he earned over \$60 million dollars, Anderson spent money on cars, houses and everything else, including a \$10,000 a month he called "hanging out money." But what really floored him was losing \$5.8 million dollars to his ex-wife Tami Roman who can now be seen flossing his cash on the show "Basketball Wives." Ouch.

Scottie Pippen was another big name who lost big. After making \$120 million dollars during his playing career he famously filed bankruptcy due in large part to a failed investment in a corporate jet. He also got screwed over by his former law firm, losing \$27 million dollars in the process.
