On a VA Form 21-0518-1, Improved Pension Eligibility Verification Report, received in September 2003, the veteran indicated that she was partly disabled due to a car accident in June 1993 in New York City.

The appellant did not respond to VA letter dated in December 2003, which due to income reporting discrepancies in her file, requested her to obtain a statement from the Social Security Administration of her income from October 1, 2002.

As a result of a June 2005 Board remand another audit was conducted of the appellant's VA widow's pension benefits from February 1, 1994 to July 30, 1997, which indicated an overpayment was created in the amount of \$18,571.00.

A letter was sent in August 2005, requesting that the appellant complete and return a VA Form 5655, Financial Status Report. The VA Form 5655 that was returned was incomplete as it did not provide the amount of the appellant's monthly income.

VA law provides that recovery of overpayment of any benefits shall be waived if there is no indication of fraud, misrepresentation, or bad faith on the part of the person or persons having an interest in obtaining the waiver and recovery of the indebtedness from the payee who received such benefits would be against equity and good conscience. 38 U.S.C.A. § 5302; 38 C.F.R. § 1.963(a). The standard "Equity and Good Conscience" will be applied when the facts and circumstances in a particular case indicate a need for reasonableness and moderation in the exercise of the government's rights. The decision reached should not be unduly favorable or adverse to either side.
