INTRODUCTION

COMES NOW, Pro Se Litigant, Kirsha Brown-Younger, filing civil suit for copyright infringement, and violations of The Copyright Act of 1976, §§ Title 17, U.S.C, Sec. 102, 106, 107, and 204, for the un-lawful and willful infringement upon her literary works, Poetry Book, "Glimpses of Life". Section §§ 411 of The Copyright Act allows, for the owner of the works to bring forth an infringement lawsuit, only if the owner has a registered copyright with the Copyright Office. Plaintiff claims that she has registered her copyright with The Library of Congress, Copyright Office in 2005, and her registration number is below:

1 Plaintiff, also claims that the above Defendants violated The Digital Millennium  
2 Copyright Act of 1998, §§ Title 17, U.S.C, and The Online Copyright Infringement  
3 Liability Limitation Act, Title II, Sec. §§ 512 3 (c), Safe Harbor.

6 STATEMENT OF FACTS  
7

8 Plaintiff claims that she submitted her Poetry Manuscript, "Glimpses of Life", for  
9 self-publishing through the website, www.LuLu.com, in 2006(if she is not mistaken).  
10 She claims that this site explained that Authors books can be uploaded, but Authors  
11 would have to self-market their own books. The site also claimed that "they do not  
12 market Authors books". Plaintiff further claims that she has recently discovered that  
13 her book has in fact been "marketed", "distributed", and "sold", by Lulu.com, thus  
14 contradicting their statements of non-marketing for Authors.

15  
16 Plaintiff, alleges, that her book was marketed, distributed and sold without her  
17 expressed knowledge, consent or permission. She claims that she had not signed a  
18 Statutory or Compulsory Licensing agreement, nor did she transfer her copyright  
19 ownership or sign a contractual agreement. She alleges that she was not notified, via  
20 email, postal mail, or by telephone, of their desire to market, distribute or sell her  
21 book to various, online or offline, book sellers or publishers. She also, claims that  
22 the number of units sold has not been cached under her account, therefore, she is  
23 unaware of the actual numbers of units sold, and that Lulu, is a dishonest and un-  
24 ethical, self-publishing company.

26 She further alleges that her book was "bought", by various online book sellers, such  
27 as:  
28

1. Amazon
2. Barnes and Noble
3. iTunes with Apple
4. I bookstore

She claims that she discovered that her book was being sold with these Book sellers, while conducting online research on 03/17/2012. She also has submitted printed copies of her book being sold on these websites.

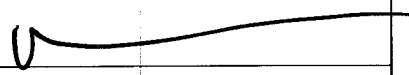
#### JURISDICTIONAL STATEMENT

Plaintiff claims 28 U.S.C, 1291, and that the Federal District Court, Northern District of Illinois, has Federal Question and Subject Matter Jurisdiction because she has alleged a violation of the Constitution or law of the United States.

#### Prayer for Relief/Damages

Wherefore, Plaintiff claims \$150,000 per works, which amounts to \$750,000, in statutory damages. However, she may need to amend/increase the amount of the judgment demand because; she may discover more booksellers/publishers that may be currently selling her book.

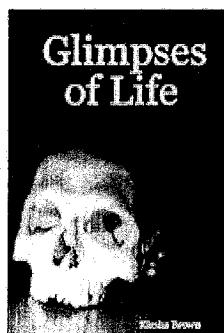
