

Upon reviewing the Contract Extension that you have sent, LoggerHead cannot move forward. This proposed Contract from you is exactly the type of Agreement that I advised in our last meeting (and subsequent emails) that we would not agree to this year. Simply there are too many issues for us to delineate in an email. This proposed contract does not reflect what we discussed with you in our previous meetings. Subsequently we have not been able to reach an agreement in time for a Fathers Day 2012 DRTV Promotion. As discussed with you on the phone repeatedly, and specified to you in previous emails, the current Fathers Day P.O.'s are at the wrong pricing, we will not accept the current Fathers Day orders placed at the 2011 pricing. Please cancel the outstanding P.O.'s at the 2011 price.

LoggerHead is withdrawing all previous pricing and subsidy offers. This program was calculated based on a committed forecast and agreed upon early Purchase Orders for 2012 DRTV Promotions allowing us the subsequent component cost savings. As we discussed the previous Promotional pricing is not sustainable. Without TV Promotion, the unit volume opportunity at Sears does not justify the subsidized pricing from LoggerHead. I have made this very clear to you in our recent discussions and emails. Thus, we have prepared the pricing below for 2012 purchases beginning on Feb 1st. 2012.

Below is our Standard Net Pricing for the products you purchase, we will not accept orders based on the previous pricing (that was heavily subsidized by us to encourage the TV Promotion). Also, we see no reason or benefit for LoggerHead to enter into a contract. In addition, I want to be clear that LoggerHead will be pursuing TV Promotions with all other possible outlets for 2012. It is our business goal to sell as many Bionic Wrenches as possible, and to create a strong business out of doing so for both our partners and ourselves. Despite my best efforts, you have failed to recognize what we bring to the table.

Please send us your end of year 2011 Subsidy calculations, and the supporting documentation as well as your VIR calculation and supporting documentation. Moving forward we want to stipulate that LoggerHead will reserve the right not to ship product if our Sears A/R is not current, or if Sears becomes a credit risk.
