- 3) That in the event Defendant fails to comply with the provisions of this Order upon motion filed by Plaintiffs, the Court shall enter judgment in the amount remaining due and owing, pursuant to the provisions of the parties Stipulation filed herewith.

4) Except as provided for in Paragraphs 1 and 2 above, this case will be dismissed, with prejudice, after April 1, 2019, and each party shall bear its own attorneys' fees and costs.
