

**Declaration/AFFIDAVIT OF STEVE WOLFF**

I, **STEVE WOLFF**, declare as follows under oath or affirmation and, declare that the following statements are true to the best of my recollection and based upon my personal knowledge, under penalty of perjury:

1. I am over eighteen years of age.
2. I have personal knowledge of the facts contained in this Affidavit/Declaration which are true and correct to the best of my knowledge.
3. I was an employee of the Seedays (Illinois) LLC (Hereinafter referred to as "Seedays"), during which time I personally observed, heard directly or became aware personally all facts and information contained herein.
4. I was an employee of Seedays and I was to be paid a salary \$8,333.00 per week before taxes and deductions. (see attached after-tax wage payments as Affidavit Exhibit 1)
5. However, beginning in January of 2015 Seedays failed to pay any wages to me from Mid-January to April of 2015.
6. During this time, January to April of 2015 I continued to work until mid-April 2015 when I quit due to non-payment of wages.
7. I am owed wage payments in accord with the Agreement between myself and Defendant.
8. The unpaid wages totals five pay periods from 1/14/15 to 4/1/15. This time period also equals a total of ten weeks of unpaid work.
9. Thus I am owed my Agreed-to salary of \$8,333.00 multiplied by five (5) for a total of \$41,665.00.
10. Additionally for the five pay periods I was paid no wages, despite working approximately 50 hours per week.
11. Thus I was paid no wages for my forty hours of work and ten hours of overtime.

I so swear, under oath, that the above statements to be true, under penalties provided by law of Section 1-109 of the Code of Civil Procedure.

If so required, I would provide testimony consistent and true to the above statements.
