AFFIDAVIT/VERIFICATION OF AMOUNTS DUE AND OWING

Dave Burgard, authorized representative for plaintiff Midstates, Inc. d/b/a Midstates Group, states that this Affidavit/Verification Of Amounts Due And Owing is made on my personal knowledge, and if I was sworn as a witness to testify at the trial of the above cause, I could competently testify to the following facts:

1. Affiant is the President and authorized representative for Midstates, Inc. d/b/a Midstates Group ("Midstates").
2. Affiant is familiar with the facts arising from and relating to this litigation and the transactions relating thereto.
3. Affiant has personal knowledge of the statements made in this Affidavit/Verification.
4. Affiant is qualified and competent to testify if called as a witness at the trial of this matter.
5. Affiant has read the Complaint. The facts alleged in the Complaint are true and correct to the best of my knowledge and belief.
6. Affiant has reviewed the exhibits and documents attached to the Complaint and to this Affidavit/Verification, and certifies that said exhibits and documents are true and correct.
7. Affiant is familiar with and has reviewed the books and records, exhibits, and other documents relating to this litigation and transactions, and said materials were generated and maintained by Midstates in the regular and ordinary course of business.

8. Midstates has made demands upon Solutions From Science for payment of the outstanding balance of \$83,515.79.

9. Solutions From Science has refused and continues to refuse to make payment.

10. Solutions From Science has breached the contract and agreement by failing to pay the balance due for said products and services with regard to the Digest job.

11. Midstates has made demands upon Matthew J. Heid ("Heid") for payment of the outstanding balance of \$83,515.79.

12. Heid has refused and continues to refuse to make payment.

13. Heid has breached the personal guarantee stated in the Application For Credit (Exhibit A of Complaint) by failing to pay the balance due for said products and services relating to the Digest job.

14. Pursuant to the Application For Credit, Heid agreed to pay a "1-1/2% service charge per month... interest charges, collection fees, court costs, and attorney's fees."

15. Midstates total damages and the balance due from Solutions From Science and/or Heid as of the date of this Affidavit/Verification are as follows:
