

**AFFIDAVIT IN SUPPORT OF MOTION FOR ENTRY OF JUDGMENT**

Pursuant to 28 U.S.C. § 1746, I, Thomas J. Coughlin, declare under penalty of perjury that the following statements are true and correct. The following statements are based on my personal knowledge based on my direct communications and interactions with the defendant, Andrew A. Vogel, and based on my knowledge and experience as a dealer in antiques and fine art. I am competent to testify on the matters stated below.

1. I am the sole member-manager of Thomas J. Coughlin Handmade European Furniture, LLC.
2. I have operated my own business of selling antiques, rare collectibles, and handmade furniture for more than fifty years. During that time, I have purchased and sold tens of thousands of such items.
3. One set of specialty items I have acquired is a selection of original Guinness art by John Gilroy, who was an in-house artist for Guinness Beer of Dublin from 1932 to 1956. These are the items I provided to Andrew A. Vogel on a consignment basis. Having sold more than three hundred such items, I am intimately familiar with the wholesale and retail values of each piece.
4. Between February 2011 and March 2015, I provided the following items to Andrew A. Vogel. Those items had, and continues to have, the values identified the following table:
