Heartland has separately isolated these documents for your convenience. However, Heartland maintains that none of these orders were caused by Heartland's allegedly unlawful conduct.

The secrecy of the comprehensive financial information contained in the Excel file is exceedingly crucial to Heartland's competitive interests. Should Heartland receive any indication that this information has been disseminated to anyone other than you or other authorized individuals, it will vigorously investigate and pursue any and all appropriate legal action against anyone involved in such unauthorized dissemination.
