- 1. I am Senior Director of Support Operations and Policy Enforcement of defendant MySpace, Inc. ("MySpace"). I have personal knowledge of the facts set forth in this Affidavit, and, if called as a witness, I could and would competently testify thereto.
- 2. MySpace owns and operates MySpace.com. Commonly referred to as a "social networking website," MySpace.com allows its members to create online "profiles," which are individual web pages where members can post information about their lives and interests along with personal photographs and videos. By



becoming "friends" with other members, MySpace.com members use their online profiles to form online communities.

- 3. MySpace.com is free to users who agree to the MySpace.com terms of use. MySpace.com does not sell products or services to its users.
- 4. MySpace, a Delaware corporation, is headquartered in Beverly Hills. MySpace has no significant contacts with the state of Indiana; it does not own or rent any facilities, offices, or property in Indiana; and it does not employ any Indiana residents. MySpace has no bank accounts in Indiana, nor does it pay taxes in Indiana.
- 5. MySpace is a wholly-owned subsidiary of Fox Interactive Media, Inc. ("FIM"). However, MySpace observes its own corporate formalities, has its own board of directors, and its own executive management team.
