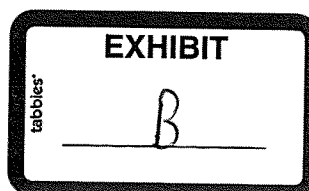

I, Marilyne Dotson, affirm as follows:



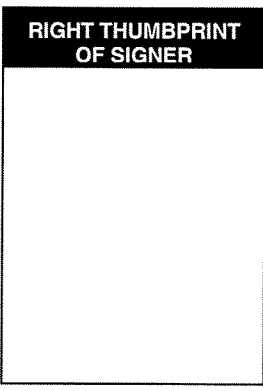
