

6. Google Inc. has established a website for receiving DMCA infringement notifications, which website is accessible at <http://books.google.com/support/bin/answer.py?answer=180577>

7. A takedown notice was submitted to Google Inc. in that fashion on September 13, 2011, in compliance with 17 USC §512(c)(3)(A).

8. Within about 9 days of receiving this takedown notice, Google Inc. had disabled public access to the material in question, in apparent compliance with 17 USC §512(c)(1)(A)(C).

9. Pursuant to 17 USC § 512(h)(2)(C), I hereby declare that the purpose for which this subpoena is being sought is to obtain the identity of an alleged infringer and that the information obtained will only be used for the purpose of protecting rights under title 17 of the United States Code.

10. I hereby declare that all statements made herein of my own knowledge are true and that all statements made on information and belief are believed to be true; and further that these statements were made with the knowledge that willful false statements and the like so made are punishable by fine or imprisonment, or both, under Section 1001 of Title 18 of the United States Code.
