Mrs. Hoosier:

The purpose of this letter is to inform you of the steps Lioness Visions, LLC has taken.

On August 16, 2010, we received your email advising us of your *departure of the company as well as informing us that you did an unauthorized withdrawal of \$380.00 from the Lioness Visions checking account. Per our contract, seventy percent (70%) of all proceeds from the book belong to Lioness Visions LLC. A portion of the money that was withdrawn without approval from the other partners was to be given to non-profit organizations from sales of the Sounds of Healing CD. You also stated that you would still be directing people to Lioness Visions in order to purchase the book as well as promoting the book for the company.*

On August 23, 2010, we responded to your letter in writing requesting all properties of Lioness Visions be returned. We accepted your resignation and advised we would address the money removed from the account without authority from the other partners money at a later time.

On August 25, 2010, you replied to our letter advising that you would comply with requests with the exception of returning the remaining copies of the book *Revealing & Healing: 3 Women's Stories of Survival* as well as any business cards.

The rights of *Revealing & Healing: 3 Women's Stories of Survival* are owned by Lioness Visions, LLC. The unauthorized withdrawal of funds from the business account has relinquished any rights that you would have had to the book and anything that is to come from the book. Therefore the complaint you filed with YouTube was a false claim.

As a reminder of our initial contract, we all agreed that all of the monies from the sales of the books would go back into the company until we reached a breakeven point. The agreement was that we would individually receive our portions of payment after all expenses were recouped, and monies from the sale of the CD, *Sounds of Healing*, were to be sent to charities.

Since you unlawfully withdrew the funds, as of August 16, 2010, you have no claim to compensation or any form of promotion in regards to that project, unless you purchase them. We are requesting a sum of \$2 million, with the first installment of \$500,000 due on December 15, 2010. The next three installments of \$500,000 are due on March 15, 2011, June 15, 2011, and September 15, 2011. Upon full payment of \$2 million, Angenita and Delina will sign over their rights to *Revealing & Healing: 3 Women's Stories of Survival*.

If you do not forward payment to purchase the rights, the legal owners of the copyrights of *Revealing & Healing: 3 Women's Stories of Survival*, Lioness Visions LLC., Angenita Childs and Delina Hill-Brooker request that you accept this letter as a formal demand that you immediately:

1. Cease and desist all promotions, marketing, or speaking of *Revealing & Healing: 3 Women's Stories of Survival* as your own work;
2. Cease and desist all mentioning of Lioness Visions, LLC as a company you started and dissolved, remove any wording on that you may have on any social networking websites in regards to this;
3. Cease and desist any and all speaking engagements regarding Lioness Visions LLC, and/or *Revealing & Healing: 3 Women's Stories of Survival*, and/or mentioning of various non-profit organizations you claim to work;
4. Return of the sum of \$380 that was withdrawn from the Lioness Visions, LLC on August 16, 2010, as well as any money earned from sales of the book and all remaining copies of the book, *Revealing & Healing: 3 Women's Stories of Survival*, and the CD, *Sounds of Healing*. The items must be mailed to Lioness Visions,

Items must be postmarked by December 31, 2010.

5. Cease and desist any recruitment initiatives; and
6. Cease any printing or copying of *Revealing & Healing: 3 Women's Stories of Survival*.


Failure to adhere to these demands will result in a suit being filed against you on the following grounds:

1. Copyright infringement
  - a. Falsely stating this is a work composed of you and you only;
  - b. Printing *Revealing & Healing: 3 Women's Stories of Survival* without clearance from Lioness Visions, LLC
2. Plagiarism
  - a. Claiming a work as your own, not giving credit to all those involved with the work
3. False advertising
  - a. Promoting the use of the book with organizations that are not formally using it
4. Defamation
  - a. Claiming you and you alone, founded Lioness Visions, LLC, and dissolved it with no regards to the other parties involved.
