COMPLAINT

"ASSAULT AND BATTERY"

"TRO TEMPORARY RESTRAINING ORDER"

Comes now the Plaintiff, Jonathan Lee Riches,[©] in pro-se, Moves this Honorable Court to issue an order for the Defendant named in this suit to respond. This is a civil rights violation suit and illegal crimes pursuant to Assault and Battery, Terroristic Threats, Stalking, harassment, and Psychological trauma. Plaintiff also moves this Honorable Court to issue a "TRO" Temporary Restraining Order against Defendant forbidding further contact with Plaintiff. Plaintiff seeks \$4,000,000,000 Billion dollars in damages from Defendant. Plaintiff prays for relief.

Plaintiff, Jonathan Lee Riches[©] is a International diamond dealer from Tampa, Florida currently staying in Selters, South Carolina

Defendant, Mike Tyson A/K/A "IRON MIKE", is the former Boxing Heavy weight champion of the world

This incident happened on MAY 6, 2007 between 11pm and 11:25 pm at JOHNSON'S night club in Cedar Falls.

Plaintiff was in town on a business trip from Holiday Florida on his way to Los Angeles California for a diamond deal. Plaintiff stopped in at JOHNSON'S for drinks, food, and lodging. Plaintiff arrived at JOHNSON'S night club at/or around 10:45 pm and sat at the main bar area. Plaintiff ordered a beer and Nachos. Plaintiff put coins in the Juke Box. Programmed the Juke Box to play 5 consecutive songs by "Michael Jackson.

At or Around 11pm that Evening, Defendant Mike Tyson A/K/A "Iron Mike" arrived at JOHNSON'S night club and immediately got everyone's attention. MR. TYSON came to the bar area where I was sitting and sat next to me. MR. TYSON said "Hello" to me and ordered a Jack Daniels. MR. TYSON was wearing black leather pants, a sailor outfit top, and a black beret. MR. TYSON appeared drunk to me, his eyes were glassy, his speech slurred. After downing a Jack Daniels quickly, MR. TYSON got up and stumbled towards the Juke Box. Tyson heard the Michael Jackson I was listening to and screamed out "who listens to this crap". MR. TYSON went in back of the Juke box, unplugged it, plugged it back in, then put coins in the machine and programmed it to play Culture club's "do you really want to hurt me". MR. TYSON stumbled back to the bar area to sit next to me.

I told MR. TYSON "Hey - You changed what I was listening to". MR. TYSON responded "so what, white boy". MR. TYSON looked intimidating to me, I felt nervous, I did not want to provoke him, so I decided not to say anything more on the issue and kept quiet. MR. TYSON then said to me "You know... You kinda cute", "Do you want to dance?", I told MR. TYSON

"NO" and let him know I was heterosexual (straight). MR. TYSON persisted by saying "Come on, just one dance." I was trying to remain calm, but MR. TYSON seemed very aggressive. I told MR. TYSON again politely "No thank you."

At or around 11:20 pm, I got up from the bar area to use the restroom. On the way to the restroom I heard foot steps behind me. When I reached the bathroom door I turned around and MR. TYSON was behind me. MR. TYSON pushed me into the restroom. The restroom door has a lock on the inside, so no one can come in from the outside if locked. MR. TYSON locked the door trapping both of us. No one else was in the restroom. My heart was pounding. I was very scared for my life. MR. TYSON said "No one says no to me" and then tried to kiss me. I told MR. TYSON to "stop". At this point MR. TYSON went into a rage. MR. TYSON grabbed me by my neck and slammed me to the floor. I was in shock and began to feel numb. I put my hands up in a defense stance, so I would not get hit. MR. TYSON leaned over me and bit the tip of my left ear. I screamed in pain. MR. TYSON seemed to be laughing. MR. TYSON said "How do you like that white boy's", I screamed for help. The music in the bar was loud, so no one could hear me. MR. TYSON then spit in my face, and kicked me in my ribs twice. I was in pain, my ear was bleeding. I thought MR. TYSON was going to kill me. MR. TYSON said "If you tell anyone about this, I will kill you". MR. TYSON backed away from me, unlocked the restroom door and left.

I layed on the floor spitting out blood from getting kicked in the ribs by MR. TYSON. I had trouble breathing. I tried to walk, but could not. I crawled out of the restroom and flagged down a female waitress for help. A female waitress called other co-workers to help me. I was lifted and layed onto a booth table. JOHNSON'S management called a ambulance.

At or Around 11:35 pm, a ambulance arrived and took me to ALLEN Memorial Hospital. When I arrived at the Hospital, staff gave me a

phone and I called the Police. Police arrived at the Hospital around 11:55 pm and I filed a police report on MR. TYSON.

Hospital doctors bandaged my left ear. I lost a piece of the top tip due to MR. TYSON'S assault. Hospital staff provided me with pain medication for bruised ribs and a headache. I was discharged from the hospital at 1:20 am on May 7, 2007. I took a cab to the Holiday Inn. I did not sleep all night. I was nervous MR. TYSON would come back and harm me. At 10:00 am on May 7, 2007, I checked out and took a cab back to Confetti's night club to get my car. I canceled my business trip to Los Angeles and drove back to Tampa Florida.


TRU Temporary Restraining Order
