MEMORANDUM OPINION

PER CURIAM.

*1 Jerrell Price claims the district court abused its discretion in imposing his sentence. Specifically, Price challenges the use of his criminal history score to enhance his sentence. Price does not challenge the district court's imposition of an upward dispositional departure. Price has moved for summary disposition pursuant to Supreme Court Rule 7.041a (2010 Kan. Ct. R. Annot. 58), and the Court of Appeals granted the motion.

Price pled guilty to one count of incest, a severity level 10 person felony. The district court granted the State's motion for an upward dispositional departure and sentenced Price to 10 months' imprisonment. Price challenges the use of his criminal history score in determining his original sentence, claiming it violates *Apprendi v. New Jersey*.

530 U.S. 466, 490, 120 S.Ct. 2348, 147 L.Ed.2d 435 (2000). This issue has already been decided by our Supreme Court in *State v. Ivory*, 273 Kan. 44, 46-48, 41 P.3d 781 (2002). This court is bound by Kansas Supreme Court precedent absent some indication that the court is abandoning its precedent. See *State v. Dawson*, 43 Kan.App.2d 800, 803, 231 P.3d 582, *rev. denied* 290 Kan. 1097 (2010). The Kansas Supreme Court has continued to affirm the reasoning in *Ivory*. See *State v. Foster*, 290 Kan. 696, 699, 233 P.3d 265 (2010) (refusing to address the *Ivory* challenge to Foster's sentence). Therefore, there is no indication that the court is departing from its precedent.
