NOW BEFORE ME, the undersigned authority, personally came and appeared

DAVID ISRAEL,

who, after being duly sworn, did depose and state:

- 1. <u>BACKGROUND</u>. I am a partner at SESSIONS, FISHMAN, NATHAN & ISRAEL, L.L.P. ("the Firm"). The Firm has a total of 34 attorneys. The Firm has offices in the following cities: New Orleans and Metairie, LA; Buffalo, NY; Chicago, IL; Dallas, TX; Fort Collins, CO; San Diego, CA; and, Tampa, FL. The Firm's main office is located in New Orleans, Louisiana, but the Firm services clients throughout the nation.
- 2. The Firm was established in 1958 by Ralph Fishman and Cicero Sessions.
