**MOTION TO COMPEL ARBITRATION AND DISMISS CLAIMS
PURSUANT TO THE FEDERAL ARBITRATION ACT**

Please take notice that on October 14, 2010, at 9:30 a.m., pursuant to the Federal Arbitration Act, 9 U.S.C. §§ 1-16, Defendant AT&T Mobility LLC (“ATTM”) will move and hereby does move this Court for an order compelling Plaintiffs Sabrina Storer and Paige Lierman to arbitrate their claims or pursue them in small claims court and dismissing their claims against ATTM. ATTM brings this motion on the ground that the Federal Arbitration Act requires Storer and Lierman to pursue their claims in accordance with their arbitration agreements.
