**DEFENDANT APPLE INC.’S MOTION TO DISMISS  
FIRST AMENDED AND SUPPLEMENTAL COMPLAINT**

NOW INTO COURT, through undersigned counsel, comes defendant, Apple Inc. (“Apple”), who moves this Court to dismiss Plaintiffs’ First Amended and Supplemental Complaint (“FAC”) with prejudice.

Apple seeks dismissal of this action on the grounds that the Plaintiffs’ FAC fails to meet the pleading requirements of Rules 8, 9 and 12 of the Federal Rules of Civil Procedure. The

FAC does not identify the particular representations regarding Multimedia Messaging Service (“MMS”) to which the Plaintiffs were allegedly exposed; it does not demonstrate that Plaintiffs relied on the supposed representations; and it does not adequately allege that Plaintiffs were caused injury thereby. Furthermore, a review of Apple’s advertisements and marketing material referenced in the FAC illustrate that Apple consistently disclosed that MMS would not be available until late summer 2009.

For these reasons, as set forth in the accompanying Memorandum of Law in Support, Apple prays that its Motion to Dismiss be granted, and this matter be dismissed with prejudice, at Plaintiffs’ cost.
