REQUEST FOR ORAL ARGUMENT

Plaintiffs, Hornbeck Offshore Services, L.L.C., the Chouest Entities and the Bollinger Entities, pursuant to Local Rule 78.1E, respectfully request oral argument on September 22, 2010, on their Renewed Motion to Enforce Preliminary Injunction Order. Based on Defendant Secretary Salazar’s public announcements immediately following entry of this Court’s June 22, 2010 Order, Plaintiffs previously filed a Motion to Enforce Preliminary Injunction Order, which

the Court denied “as premature.” Rec. Docs. 68, 69 and 82. Since the Court’s denial of the Plaintiffs’ motion, Defendants have issued their promised second moratorium and have unsuccessfully sought to have this case dismissed as moot. Rec. Doc. 165.
