ORDER & REASONS

Before the Court is BP's *Daubert* Motion to Exclude the Causation Testimony of Plaintiff's Expert, Dr. Jerald Cook<sup>1</sup> filed by Defendants BP Exploration & Production Inc., BP America Production Company, and BP p.l.c. as well as Defendants' Motion for Summary Judgment.<sup>2</sup> Halliburton Energy Services, Inc., Transocean Holdings, LLC, Transocean Deepwater, Inc., and Transocean Offshore Deepwater Drilling, Inc. (collectively "Defendants") have joined in both motions.<sup>3</sup> Plaintiff Dalan Lenard ("Plaintiff") opposes both Motions.<sup>4</sup> Defendants have filed Replies in support of their Motions and Plaintiff has filed a Supplemental Memorandum in Opposition to BP's *Daubert* Motion to Exclude the Causation Testimony of Plaintiffs' [sic] Expert, Dr. Jerald Cook.<sup>5</sup>

After careful consideration of the parties' memoranda, the record, and the applicable law, the Defendants' Motions are **GRANTED**.

## I. FACTUAL & PROCEDURAL BACKGROUND

This case arises from the *Deepwater Horizon* oil spill in the Gulf of Mexico in 2010 and the subsequent cleanup efforts of the Gulf Coast. On January 11, 2013, United States District Judge Carl J. Barbier, who presided over the multidistrict litigation arising out of the *Deepwater Horizon* incident, approved the *Deepwater Horizon* Medical Benefits Class Action Settlement Agreement (the “MSA”).<sup>6</sup> However, certain individuals, referred to as “B3” plaintiffs, either opted out of or were excluded from the MSA.<sup>7</sup> Plaintiff Dalan Lenard opted out of the MSA and, accordingly, is a B3 plaintiff.<sup>8</sup>

Plaintiff filed this individual action against Defendants on April 18, 2017 to recover for injuries allegedly sustained as a result of the oil spill.<sup>9</sup> For approximately three months in 2010, Plaintiff worked as a beach cleanup worker, tasked with cleaning up oil and oil-covered debris from the beaches and coastal areas in Gulfport and Biloxi, Mississippi.<sup>10</sup> Plaintiff alleges that Defendants’ negligence and recklessness in both causing the Gulf oil spill and subsequently failing to properly design and implement a clean-up response caused him to suffer myriad injuries including frequent urination, diarrhea, nausea, abdominal pain, headaches, dizziness, shortness of breath, cough, sinus congestion and drainage, decreased sense of smell, skin dryness/flaking, inflammation, redness or swelling, itching, peeling,

and scaling.<sup>11</sup> Specifically, Plaintiff seeks to recover economic damages, personal injury damages—including damages for past and future medical expenses and for pain and suffering—punitive damages, and attorneys’ fees, costs, and expenses.<sup>12</sup>

To help support his claims that exposure to the chemicals present in the oil spilled by Defendants caused his particular health symptoms, Plaintiff offers the report (“Report”) and testimony of Dr. Jerald Cook.<sup>13</sup> Dr. Cook is a retired Navy physician with expertise specifically as an occupational and environmental physician.<sup>14</sup> Dr. Cook’s Report is not tailored directly to Plaintiff’s claims; rather, Dr. Cook’s generic causation Report has been utilized by numerous B3 plaintiffs, including many plaintiffs currently before this Court as well as in other cases before other sections of this court.<sup>15</sup> Accordingly, Dr. Cook’s Report pertains only to general causation and not to specific causation.<sup>16</sup>

Defendants filed the instant Motion *in limine* and Motion for Summary Judgment on September 19, 2022. In their Motion *in limine*, Defendants contend that Dr. Cook should be excluded from testifying due to, *inter alia*, Dr. Cook’s failure to identify the harmful level of exposure capable of causing Plaintiff’s particular injuries for each chemical that Plaintiff alleges to have been exposed to. Because Dr. Cook should be excluded from testifying, Defendants argue, the Court should grant

their Motion for Summary Judgment as Plaintiff is unable to establish general causation through expert testimony, a necessary requirement under controlling Circuit precedent. Plaintiff opposes both Motions, arguing that Dr. Cook's Report satisfies the *Daubert* standards for reliability and relevancy and, therefore, that summary judgment is inappropriate.

## II. LEGAL STANDARD

### A. Motion *in Limine*

The district court has considerable discretion to admit or exclude expert testimony under Fed. R. Evid. 702,<sup>17</sup> and the burden rests with the party seeking to present the testimony to show that the requirements of Rule 702 are met.<sup>18</sup> Rule 702 provides that an expert witness “qualified . . . by knowledge, skill, experience, training or education may testify in the form of an opinion” when all of the following requirements are met:

- (a) The expert's scientific, technical, or other specialized knowledge will help the trier of fact to understand the evidence or to determine a fact in issue;
- (b) The testimony is based on sufficient facts or data;
- (c) The testimony is the product of reliable principles and methods; and
- (d) The expert has reliably applied the principles and methods to the facts of the case.<sup>19</sup>

Rule 702 codifies the Supreme Court's opinion in *Daubert v. Merrell Dow Pharmaceuticals, Inc.*, which charges district courts to act as “gatekeepers” when

determining the admissibility of expert testimony.<sup>20</sup> “To be admissible under Rule 702, the court must find that the evidence is both relevant and reliable.”<sup>21</sup> According to the Fifth Circuit, reliability is determined by assessing whether the reasoning or methodology underlying the testimony is scientifically valid, while relevance depends on whether the reasoning or methodology underlying the testimony can be properly applied to the facts at issue.<sup>22</sup> The purpose of the reliability requirement is to exclude expert testimony based merely on subjective belief or unsupported speculation.<sup>23</sup>

To satisfy the reliability prong of the *Daubert*/Rule 702 analysis, a “party seeking to introduce expert testimony must show (1) the testimony is based upon sufficient facts or data, (2) the testimony is the product of reliable principles and methods, and (3) the witness has applied the principles and methods reliably to the facts of the case.”<sup>24</sup> To prove reliability, the proponent of the expert testimony must present some objective, independent validation of the expert’s methodology.<sup>25</sup> The objective of this Court’s gatekeeper role is to ensure that an expert “employs in the courtroom the same level of intellectual rigor that characterizes the practice of an expert in the relevant field.”<sup>26</sup>

## B. Summary Judgment

Summary judgment is appropriate under Federal Rule of Civil Procedure 56 “if the movant shows that there is no genuine dispute as to any material fact and the movant is entitled to judgment as a matter of law.”<sup>27</sup> When assessing whether a genuine dispute regarding any material fact exists, the Court considers “all of the evidence in the record but refrain[s] from making credibility determinations or weighing the evidence.”<sup>28</sup> While all reasonable inferences must be drawn in favor of the nonmoving party, a party cannot defeat summary judgment with conclusory allegations, unsubstantiated assertions or “only a scintilla of evidence.”<sup>29</sup> Instead, summary judgment is appropriate if a reasonable jury could not return a verdict for the nonmoving party.<sup>30</sup>

If the dispositive issue is one on which the moving party will bear the burden of proof at trial, the moving party “must come forward with evidence which would entitle it to a directed verdict if the evidence went uncontroverted at trial.”<sup>31</sup> The non-moving party can then defeat summary judgment by either submitting evidence sufficient to demonstrate the existence of a genuine dispute of material fact, or by “showing that the moving party’s evidence is so sheer that it may not persuade the reasonable fact-finder to return a verdict in favor of the moving party.”<sup>32</sup> If, however,

the nonmoving party will bear the burden of proof at trial on the dispositive issue, the moving party may satisfy its burden by merely pointing out that the evidence in the record is insufficient with respect to an essential element of the nonmoving party's claim.<sup>33</sup> The burden then shifts to the nonmoving party who must go beyond the pleadings and, "by her own affidavits, or by the 'depositions, answers to interrogatories, and admissions on file,' designate 'specific facts showing that there is a genuine issue for trial.'"<sup>34</sup>

### III. ANALYSIS

The burden of proof is on the B3 plaintiffs to prove that "the legal cause of the claimed injury or illness is exposure to oil or other chemicals used during the response."<sup>35</sup> To prove causation, the B3 plaintiffs are required to provide reliable expert testimony.<sup>36</sup> "A plaintiff in such a case cannot expect lay fact-finders to understand medical causation; expert testimony is thus required to establish causation."<sup>37</sup>

Courts use "a two-step process in examining the admissibility of causation evidence in toxic tort cases."<sup>38</sup> First, a court must determine whether general causation exists.<sup>39</sup> "General causation is whether a substance is capable of causing a particular injury or condition in the general population."<sup>40</sup> Second, if the court finds

that there is admissible general-causation evidence, “the district court must determine whether there is admissible specific-causation evidence.”<sup>41</sup> “[S]pecific causation is whether a substance caused a particular individual’s injury.”<sup>42</sup> If the court finds that there is no admissible general causation evidence, it need not consider the issue of specific causation.<sup>43</sup>

To establish general causation, a causation expert must identify “the harmful level of exposure to a chemical” at which physical symptoms manifest.<sup>44</sup> As explained by Dr. Cook, nearly every chemical on Earth may be toxic or even fatal at a certain level of exposure.<sup>45</sup> Thus, causation experts determine not only *whether* a chemical is capable of causing certain health effects, but *at what level* of exposure do those health affects appear. Experts, such as Dr. Cook, refer to this inquiry with the maxim, *dosis sola facit venenum*, or “the dose determines the poison.”<sup>46</sup> This analysis is also referred to in the Bradford Hill factors as the dose-response relationship.<sup>47</sup>

In recognition of the importance of this step of the causation analysis, the American Medical Association’s *Guide to the Evaluation of Disease and Injury Causation* states that determining “whether the estimated dose was sufficient to

explain observed clinical effects known to be associated with the agent in question” is the “most critical phase of the hazard evaluation process.”<sup>48</sup> Relatedly, the Fifth Circuit states that this detail is one of the “minimal facts necessary to sustain the plaintiff’s burden in a toxic tort case.”<sup>49</sup> Plaintiffs must provide reliable expert testimony establishing the requisite level of exposure necessary to cause each alleged physical harm.<sup>50</sup> Accordingly, failure to properly identify the level of exposure to a particular chemical at which harmful effects occur necessarily renders a general causation opinion unreliable and, thus, inadmissible.<sup>51</sup>

This Court has not previously considered the May 31, 2022 version of Dr. Cook’s Report offered here by Plaintiff. However, the Court has previously addressed the June 21, 2022 version of Dr. Cook’s Report, finding that that version fails to meet the *Daubert* standards for reliability and helpfulness to the trier of fact.<sup>52</sup> The Court has reviewed the earlier May 31, 2022 version of Dr. Cook’s Report and finds that it too suffers from the same flaws as the later version.<sup>53</sup> For the same reasons set forth

in detail in the Order and Reasons discussing the June 21, 2022 Report, the Court determines that Plaintiff has failed in his burden of establishing the reliability and relevance of his expert's report and finds it appropriate to grant Defendants' Motion *in limine* to exclude Dr. Cook's Report. Plaintiff accordingly lacks expert testimony on general causation. Without expert testimony, which is required to prove general causation,<sup>54</sup> Plaintiff has failed to demonstrate a genuine dispute of material fact regarding his claims that his injuries were caused by exposure to oil. "When a plaintiff has no expert testimony to prove his medical diagnosis or causation at trial, the plaintiff's suit may be dismissed at the summary judgment stage."<sup>55</sup> Thus, Defendants' Motion for Summary Judgment must be granted as Defendants are entitled to judgment as a matter of law due to Plaintiff's failure to establish general causation.

#### IV. CONCLUSION

**IT IS HEREBY ORDERED** that Defendants' *Daubert* Motion to Exclude the Causation Testimony of Plaintiff's Expert, Dr. Jerald Cook<sup>56</sup> is **GRANTED**.

**IT IS FURTHER ORDERED** that Defendants' Motion for Summary Judgment<sup>57</sup> is **GRANTED**.
