Clerk,

Rational people wouldn't place another individual's private medical information on the Internet for public consumption. In December 2010, I provided a written request asking that my appeal be dismissed, but on February 15th, 2011, judges McClanahan, Haley, and Willis, within minutes of ruling on my case, instructed their staff to edit their ruling to withhold medical details of "white defendants" involved in the appeal, and to intentionally include specific details of my personal medical history, to be published on the Internet. This racist and cowardly action, is a prime example of the evolution of racism within the state of Virginia.

Recently, I was informed by a Clerk of the Virginia Court of Appeals [Justin Eugene Shelton] that the HIPPA Laws don't apply to the Virginia Court of Appeals, and that my December 25th, 2010 letter asked the Court to dismiss this case, was of no interest to the Virginia Court of Appeals. In addition, months before the Virginia Court of Appeals' posting of my medical information on the Internet, I was warned by various employees at the Virginia Court of Appeals that due to errors made in the filing of the appeal, the case was dead. The Virginia Court of Appeal's Internet posting of my medical issues was an intentional scheme to teach a "Negro" never to talk back to "white folk". - 1. How would Judge Elizabeth A. McClanahan react, if she found that her medical information detailing alleged breast cancer or abortions, was placed on the Internet in a malicious manner?

- 3. How would Judge Jere M.H. Willis react, if he found that his medical documents detailing alleged Alzheimer's disease and vision issues, was placed on the Internet in a malicious manner?

We will date-stamp the replacement pleadings with the filing date of the original. We require a total of seven copies and you must send one copy to your opponent. See Rule 5A:19(f).

Please be advised that this notification may not address all deficiencies contained in the opening brief and the Court is not precluded from taking action with regard to any noncompliance of the brief with the Rules of Court, including those Rules addressed in this notification.

On August 25, 2010 the appellant, in proper person, filed an opening brief in this case.

On September 14, 2010 the clerk's office of this Court notified appellant that the opening brief was not in compliance with the Rules of Court because, *inter alia*, the brief did not contain assignments of error. See Rule 5A:29(c).

On October 25, 2010 appellant, in proper person, filed a replacement opening brief.

Upon review of the replacement opening brief, the Court notes that the opening brief continues to contain "questions presented" rather than "assignments of error." Appellant should be advised that merely titling a portion of the opening brief "assignments of error" will not constitute compliance with this rule. The Rules of Court define "assignments of error" as "the specific errors in the ruling below upon which the party intends to rely." See Rule 5A:12(c)(1). Assignments of error cannot be stated in question form; they must be stated in the affirmative. (Example: "The commission erred in finding that . . . .")

In addition, the text of the replacement opening brief filed on October 25, 2010 varied from that of the original opening brief. This Court's September 14, 2010 notification indicated that "the replacements must be clearly labeled as such and the text of the replacements must not vary from that

of the original pleading except as may be necessary to correct the deficiencies noted" (emphasis added).

Accordingly, appellant is directed to file a second set of replacement opening briefs within ten days of the date of entry of this order. The replacements must be clearly labeled as such and the text of the replacements must not vary from that of the original opening brief except as may be necessary to correct the deficiencies noted in the September 14, 2010 letter and this order. A total of four copies are required and one copy must be sent to opposing counsel.

Appellant should also be advised that this order may not address all deficiencies contained in the opening brief and the Court is not precluded from taking action with regard to any noncompliance of the opening brief with the Rules of Court, including the Rules addressed in this order.
