was deactivated from 1969 when cell phones were not even out which I sent to The US District Court for Maryland a copy of the phone lockout .Now after the deposition June 19 of 2017 here I go again all the emails that I had all gone wiped out since 1969 again it was gone then when I looked on my email after a deposition it's all been wiped out again since 1969 I feel that the defendant's counselor/attorneys have something to lose because every time I gave the US District Court any evidence even the deposition everything gets wiped out and The defendants attorney asked me about my phone and I told him it didn't work no more I am formed the defendants attorney that I had emails and that I was going to go home and look at everything ended up being in the trash and subject for delete from 1969 I noticed it I saw Mr. Parker E. Thoeni Response back to my deposition but then when I looked again it was gone I had to find it in the trash and then I found all the other emails that were deleted and in the trash and wiped out. I feel very very abused by the defendant Keller Transportation and Charles County School Board because I've never seen anyone who would stop you mail deleted you mail and phone. if all the allegations were not true then Keller Transportation wouldn't have anything to hide Helen Keller, Ernie Keller jr , E.Keller III i'm tired of my rights being valued it at this point give me liberty or give me death because my inherited rights have been violated too

EEOC complaint was made March 11, 2016 I can prove that I resigned April 14, of 2016 while I was on a work injury and I was calling out every under uninsured worker because I was put in as independent contractor once again illegally and under a group insurance pool. I the plaintiff just complaint to the states attorney because I am being harassed by Keller Transportation and The Charles county school board they are

blocking all my emails from going or coming they are deleting my routers every time I get a new one. I have a letter on my car my house door was open then also the school trying to get my son Joshua Waters to have me voluntarily sign a waiver to waive to give up my rights with Comcast and Charles county school board and I did not sign that waiver I went to the states attorneys office in Charles County court they informed me that they move my EEOC case to Goldsboro without my permission The states attorneys office and Charles county Maryland said it was a federal case how can attorneys move a case to Goldsboro out of the jurisdiction and then get the case dropped for lack of jurisdiction and subject matter. I don't live in Goldsboro and also Keller bus sent me paperwork claim and I live in St. Mary's County and they assistant living program Keller bus they all tell lies I act like I live at a different area take over my email account take over my phone cut it off and on take my mail and move me out of the area.

It is illegal to move my case out of that area change the mailing address stop my email delete the port delete my phone number and put them in Keller bus service programs under their custody control which is all done

illegal they should be in jail for this. I am being harassed on a daily basis and they're not going to stop until a high authority as the judicial court system is in place to make sure this in justice doesn't happen to the citizens of this country.

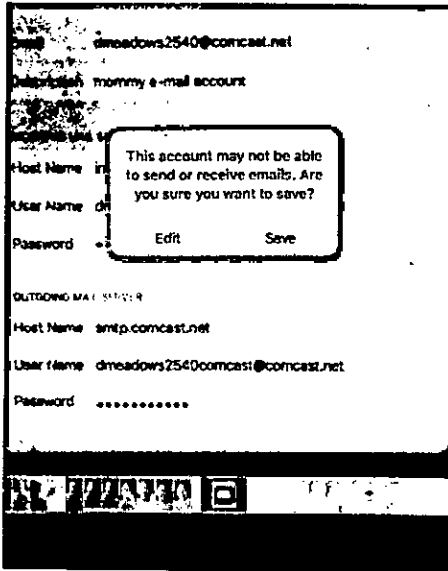

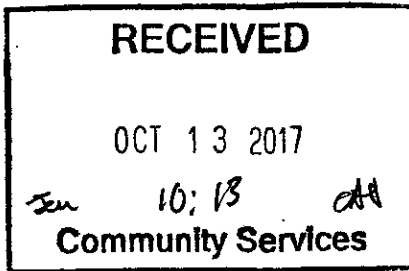

he claimant has shown, by a preponderance of the credible evidence, that she voluntarily quit her position for documented medical reasons caused by her employment. Since this reason was connected with the conditions of the employment, it can constitute good cause within the meaning of the Maryland Code Annotated, Labor and Employment Article, § 8-1001. Accordingly, I hold the claimant's voluntary quit was for good cause and benefits are, therefore, allowed.

DECISION

IT IS HELD THAT the claimant's unemployment was due to leaving work voluntarily but with good cause within the meaning of Maryland Code Annotated, Labor and Employment Article, § 8-1001. My name is Debra Meadows and I am sending you this appeal on behalf of my son Joshua Waters who was removed from Thomas Stone and I will quote exactly what Ms Benson put in the letter that she handed him on September 21, 2016, in her office and I quote: "I am exercising my authority under state law to remove your child, Joshua Waters, from Thomas Stone High School in order to maintain a safe and secure school environment for staff and other students until his second degree assault charge is adjudicated".

This is truly out of order when Joshua is a straight A student and has never been in any trouble at Thomson Stone and you can check his records and with his teachers regarding his character. Also, the incident in which Ms. Benson is using happen in our housing development a good ways from the school grounds on September 12, 2016. Joshua was helping a female friend who asked him to help her get a male friend out of her house while her mother was not at home. This is truly unacceptable at anytime but especially now with this being Joshua's senior year.

Not only was Joshua removed from Thomas Stone, the school system now adds a more ridiculous solution to an unmerited action and that is to put him in a **Home Hospital** as a terminally ill cancer patient per Mr. E. Coles at (240)346-8542. On September 22, 2016, Mr. Coles called me Debra Meadows (mother of Joshua Waters) and said he was assigned as the home teacher for Joshua Waters and asked me if he was severely retarded and I told him no – he then informed me that he was coming out for a terminally ill cancer patient. The very next day on September 23, 2016, I received a call from Health Human Services (301) 435-5000 wanting to setup a day to install a surveillance camera at my home for a severely terminally ill patience. Now it does not take a rocket science to know that the before mention does not describe my son Joshua Waters. I never heard of this program before so I looked into House Hospital after both calls and I quote from the CCBOE Home Hospital website: . This service is available ... to students with temporary and emotional conditions or chronic health impairments that adversely affect school performance" once again the before mention does not describe my son Joshua or his actions. To further quote from the Home Hospital website on 3. " **What is the process for referring a student?** Referrals are made directly to the Home and Hospital instruction office using the appropriate CCPS forms. All applications **must be signed by parents and the certifying professional**. Once the application is **completed and returned** to the school system, instruction will begin within ten (10) calendar days. " I want to know who put Joshua in this program because it definitely was not me.

Anyone at Thomas Stone High School could clearly see that the records (if) they were used and whatever other criteria was used for Home Hospital could not possibly be for Joshua Waters

I expect Joshua Waters to be reinstated to Thomas Stone immediately to complete his senior year and for the Home Hospital issue to be terminated and all paperwork showing all authorizations and termination actions forwarded to me Debra Meadows the parent of Joshua Waters.


