11.4 Failure on the part of the CONTRACTOR to submit and verify all in accordance with 7.6.1. required documentation by the established due date shall be cause for the CCPS to withhold payments due the CONTRACTOR, on the bus (is) in question, until such documentation is satisfactorily submitted.

11.5 Any changes to other terms of this agreement must be in writing and signed by both the CCPS and CONTRACTOR.

12. PENALTIES

12.1 In the event, Time-Mileage reports are not received in accordance with paragraph 7.6.1; a penalty will be applied as follows:

12.1.1 In the event a time and mileage report is not received within 15 business days from the assigned effective date a penalty will be applied. The penalty will begin on the 16th day. The said bus contractor will be levied a five dollar a day penalty for every business day beyond the due date provided. All reports must be signed by the driver and certified CONTRACTOR for correctness.

13. MISCELLANEOUS PROVISIONS

13.1 CONTRACTORS will provide the CCPS with a completed Department of the Treasury, Internal Revenue Service Form W-9. (Form attached).

After due consideration of the above entitled case, it is determined that the claimant sustained an accidental injury or occupational disease/illness as defined in Section 9-101 (b) or (g), Labor and Employment Article, Maryland Annotated Code, arising out of and in the course of employment on 11/02/2015 that the average weekly wage was \$459.44 and that the claimant was temporarily totally disabled as a result of said injuries.


The Commission has concluded to pass an ORDER based on the evidence in the record, but will reserve the right of both parties to have the issue of average weekly wage Adjudicated at the first hearing before the Commission.

It is, therefore, this day 02/19/2016 by the Workers' Compensation Commission ORDERED that the said employer and insurer:

1. Pay unto the said claimant compensation at the rate of \$307.00 per week, payable weekly, during the continuance of the temporary total disability of the claimant. Said compensation to begin on 11/06/2015 provided, however, that the injury results in disability of more than 14 days, compensation shall be paid from the date of the disability including the day the injury occurred; subject to a credit for the days the claimant worked and received wages.
 2. Promptly provide said claimant medical treatment and the other necessary medical services as provided by Section 9-101 (b) or (g), Labor and Employment Article, Maryland Annotated Code.
 3. When the claimant receives medical care from a physician of his or her selection, he or she shall provide medical reports and invoices to the insurer.
- This Award is subject to further determination by this Commission as to whether or not the claimant has sustained any permanent disability.

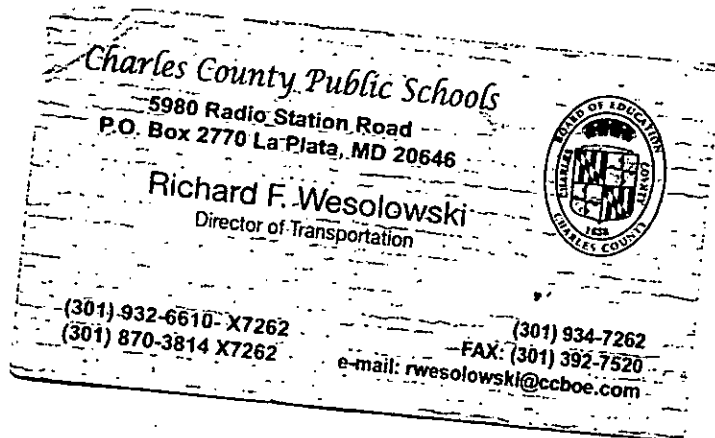

Wednesday, April 1 will be a two-hour early dismissal day for students and afternoon prekindergarten students attend that day.** ~~The school system has used seven inclement weather days so far this school year, of which only four are built into the school calendar. The use of spring break days for lost instructional time is outlined in the Charles County Public Schools Parent Handbook/Calendar annually.~~

Schools will be closed for spring break April 2-6, and reopen on Tuesday, April 7. Maryland law requires school to operate 180 days for students each school year. The school system builds four inclement weather days into its calendar each year, which are deleted from the end of the year if not used. All days have been used this school year, making Tuesday, June 16 the last day of school for students.

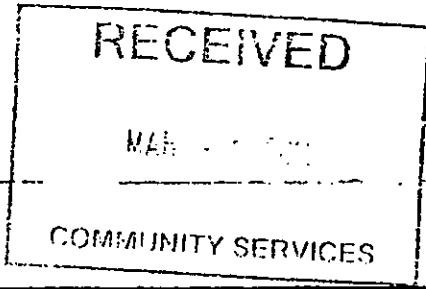
