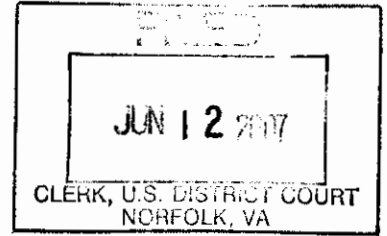

BLOCKBUSTER, TIVO, AND NETFLIX' JOINT MOTION TO TRANSFER VENUE




