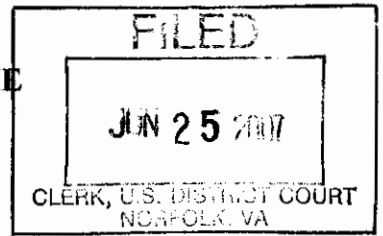

3. The time for plaintiff to file its responsive brief and for defendants to file their rebuttal brief to the Motion to Transfer Venue has not passed.


4. An Agreed Order is being circulated for endorsement and will be submitted to the Court promptly.


