REPORT AND RECOMMENDATION ON PLAINTIFF'S MOTION
TO DISMISS DEFENDANT BERNARD A. KANSKY'S COUNTERCLAIM

September 4, 2013

SOROKIN, C.M.J.

In this action, the government seeks to reduce to judgment more than \$200,000 in alleged federal income tax liabilities of defendant Bernard A. Kansky, and to enforce related federal tax liens via judicial sale of two properties in which Kansky has an ownership interest.¹ See generally Doc. No. 1. Kansky has asserted a counterclaim seeking monetary damages from the government for "Intentional Reckless Conduct - Physical Harm and Emotional Distress." Doc. No. 17 at 11. When it answered the counterclaim, the government listed affirmative defenses based on sovereign immunity and failure to exhaust administrative remedies, both of which it noted were jurisdictional defects.² Doc. No. 35 at 1.

On July 31, 2013, the government filed a motion seeking dismissal of the counterclaim, citing lack of subject-matter jurisdiction and, alternatively, failure to state a claim upon which

10/5/13 I adopt the report and recommend and dismiss the counterclaim. Paul B. Saris
