Patrick: We are going to use much of what you said in your expert report in your declaration in support of the motion for summary judgment, but I also want you to see the declarations they filed. There are statements in there that just are outright untrue. Hoffman ¶ 5 – the recording agreement contemplated that Eminem would write compositions – completely untrue. It contemplates recording – Aftermath isn't his publisher. I don't know that there is much you can say about Wang's declaration but take a look anyway if you would.

Also, I'm curious – the HFA licenses to the extent they license anything are for the U.S. only. There are several other agreements none of which are applicable as Aftermath would like, but they also limit the reproduction and distribution to U.S. and Canada.

Shouldn't we say something about a license being for a specific territory? Thank you very much.
